## \*1) Capt. Alvin Clark 1852

The Alvin Clark Company left Sugar Grove, Mercer County, Illinois in April 1852. Their journey is documented in a publication called Across the Plains and Beyond by Ruth Conard, a descendant who reportedly was working from the diary of Alvin Clark. The publication is written as a narrative and while it may be of interest to descendants it is not for the serious researcher.

The company began their journey west from Kanesville (Council Bluffs), Illinois on May 5, 1852. They reached Fort Laramie June 15 and Independence Rock June 25<sup>th</sup>. They arrived at Pacific Springs July 12<sup>th</sup> and Soda Springs July 17<sup>th</sup>. The rest of the publication does not mention dates except for the notation that they reached Burnt River August 23 and Oregon City October 2, 1852.

On the Oregon Donation Land Claim applications the arrival dates vary for the various company members from September 28 to October 2. The women and children of the company reportedly went down the Columbia River while the men took the Barlow Road. The first half of the publication addresses the journey and the members of the train, while the second half focuses on the timeline after arrival and Clark's religion and attempts to establish a church. Their destination was Benton County where they hoped to join family members who had made the trip in previous years.
