### Killed by Indians.

The Grant County News has the following in regard to the finding of the remains of a man supposed to be Rice Pendleton, formerly of this county: "On the 29th day of April last, or one week since, having occasion to go to the house of Mr. John Brisbois in company with Mr. Joseph Hodson we were surprised and almost horrified to learn as soon as we arrived there, that the remains of a white man had been found by Mr. Brisbois on the 21st of April, and buried on the 24th. Mr. B. being alone, went to Beaver creek to get some one to assist him in burying the remains. Mr. James Rager and Mr. Philander Mann came over and assisted in the performance of the last sad cites. Mr. Brisbois is confident that the remains are those of a man by the name of Rico Pendleton, formerly a resident of Lane county, at or near Eugene City. Supposed to be , bout 48 years of age. A member of Eugene Lodge, No. - I. O. O. F., also a granger. Mr. Brishois and Oliver Hyde had seen his card taken from his Lodge and read the same. Mr. Brishols was not positively certain as to his christian name, but knew it to be Rice, Reis or Reese. Deceased has a sister living at or near Eugene or Oregon City. There is no doubt but what he was killed by the Indians as they passed through on the 27th or 28th of June last. He either aid not know that the Indians were hostile, or came to warn Brisbois and the Hyde Brothers of their danger.



OBERT WHITNEY, a pioneer of 1817, and one of the prominent farmers of French Prairie, is a native of the State of Indiana, born in La Grange county, December 28, 1831. He is of English accestry, his father, William Whitney, having been born in Lincolnshire in the year 1807. He married a hady of his own country, Miss Elizabeth Taylor, who was three mouths younger than himself.

In 1828 William Whitney came to the United States, to push his fortunes, and in 1830 he sent for his wife and child, and after they came they settled in the State of New Jersey. In 1832 they went to Pennsylvania, where they resided for two years, and in 1834 removed to Indiana, where they remained nine more, but in 1847 Mr. Whitney with his little family crossed the plains to Oregon. The children then were: Joseph, Robert, James, Elizabeth, Sarah and Alice. After a journey of six months' duration they arrived safely at French Prairie, in Marion county, where he purchased a settler's right to a donation claim of 640 acres of choice land, from a Mr. Barnard. Upon this place was a log house, and thirty acres of this place was fenced.

When the Whitney family began pioneer life in the new country it was but sparsely settled, but the following year gold was discovered, and with a few of his neighbors he made the jonrney overland to California, in 1848, and engaged in mining on the Moquelumne river. Here he remained about six months, undergoing much hardship, but returned with \$1,200 in gold. He then turned his attention to farming, and became the owner of other tracts of land, and later in life he gave these to his children. His death occurred June 1, 1878, his good wife having passed away April 6, 1875. They were kind, hospitable people, well and widely known by the pioneers, and enjoyed the esteem of all who knew them. Robert was the fourth child in the family of his parents, and was in his thirteenth year when he accompanied his parents to Oregon. Here he attended school, but later entered the mines at Florence City, and in 1864 at Boice, where he worked the most of the time for wages, receiving \$100 per month. He was married February 12, 1866, to Miss Hannah Pendleton, a native of Logan county, Illinois, born January 16, 1837, a daughter of Mr. Champney Pendleton, who with his family came to Oregon in 1847, settling on a donation claim on Baker's Prairie, where he died in 1857, his wife having died in 1882, in her sixty-seventh year.

After marriage Mr. and Mrs. Whitney settled on the present farm of 590 acres, they having purchased it from his father, paying down \$3,000, and going in debt \$2,200, at 6 per cent.; and this debt bas all been paid, and other land, amounting to sixty-three acres, were added; but now, after selling some of it, there remain

544 acres, and it is one of the choicest farms in the county. In 1876 our subject built a good residence on the property, and has lately turned his attention to hop-raising. Mr. and Mrs. Whitney have had uine children born at their present home, and their names are as follows: George Washington; Clara B.; Oliver C.; Ardala M., now Mrs. Joseph F. Barnes, residing near her parents; Asa; Clarence; Andrew Love; Goldsby Honesty; and Lincoln.

Mr. Whitney is in politics a Republican, and he and his oldest son are members of both branches of the I. O. O. F. and of the K. of P. This family is one of the highest credit, and one that is deserving of the esteem in which it is held through Marion county.

# MURDERER WILL SOON KNOW FATE

The Testimony Is Concluded and Attorneys for the Defense and Prosecution Argue.

Mother of Murdered Man Placed on Witness Stand by Prosecution—Crowds Throng Courtroom Waiting for Verdict of the Jury.

Late this affernoon the fute of Orlando Sherman Murray, charged with murder in the first degree for killing Lincoln Whitney, was submitted to the jury. It is expected that a verdict will be reached today, for the deliberations upon the unwritten law are expected to be brief.

After hours of tearful pleading for the youthful defendant and hitter denunciation of his crime by the prosecution, the case was finally completed this afternoon. It was in justification of the unwritten law and sympathy for one so madly perplexed as the defendant that Attorneys Logan and Jeffrey pleaded; it was to uphold the statutes made and provided that Deputy District Attorney Hancy and Attorney Vaughn argued so earnessiy.

At the court house, awaiting the verdict, are through of persons, friends of the avenger and friends and relatives of the one who is dead. Throughout

the day they crowded the court room and hallways nearby and few deserted the building after the trial was completed.

Witnesses in Rebuttal.

Testimony was concluded during the forenoon session. Several witnesses were introduced by the prosecution in rebutting the testimony given yesterday by Mary Murray and her father, Dr. O. S. Murray. Among the number were Mrs. Alice Whitney, sister-in-law of Lincoln Whitney; Mrs. Hannah Whitney, his mother; Miss Clara Whitney, his sister; Dr. Harry Lane, mayor of Portland, and Deputy District Attorney Charles L. McNary of Marion county.

A striking figure was Mrs. Hannah Whitney as she told her story. Heavily veiled and in deep mourning for her son, she told what she could to justify her

son.

"If the dead could only speak," she said, as she pointed her finger dramatically at Logan, but was quickly interpreted by the court. Her testimony was confined to a conversation that was afleged to have taken place at the time of the visit of Dr. Murray and his daughter to the Whitney home near Hubbard.

### Mayor Lane Doesn't Appear.

Dr. Lane was subpoensed, but failed to appear. His testimony was desired in rebuttal to Dr. Manion, who yesterday testified that a man under conditions similar to those that surrounded Murray at the time of the crime was crazy. Attorneys for the defense agreed to admit that Dr. Lane would testify

to the contrary.

The deputy district attorney of Marion county, upon whom Mrs. Murray her son and daughter had called, was also subpoenned. He was delayed, however, by the failure of his train to reach the city on time. His testimony was also admitted to the effect that he told Mrs. Murray that he would cause the issuance of a warrant for Whitney's arrest and cause his prosecution.

The woman insisted that she did not

desire the prosecution of the young man and refused to sire a complaint.

Bert E. Haney opened the arguments in behalf of the prosecution. He urged upon the jurors that they remember the oath to try the case fairly and cautioned them against permitting their sympathy to influence them in arriving at a verdict. He confined himself to a discussion of the points of law involved.

### Logan's Touching Plea.

John F. Logan, for the defense, followed Mr. Haney. His address was scarcely an hour in duration, but at the conclusion handkerchiefs were in use, not only by the large number of women in the vast audience, but even by the jurors. He began his address by quoting a portion of President Roosevelt's annual message. He read thatportion of the message dealing with the crime of which the defense accuses Whitney, which crime the president said was the most beinous crime of all, and one that should be punished with death. It was such a crime, Mr. Logan said, that Lincoln Whitney had committed.

Mr. Logan next called attention of the jurors to the constitution of the state, which provides that jurors are the judges of the law. It rested with them, he said, to decide whether a crime had been committed and whether or not the law had been violated. In conclusion he drew a vivid picture of the home in University Park, where the Murray family would tonight await the return of Sherman, their son, the support and bread winner of the famfly.

### Other Arguments Reard.

Mr. Jeffrey resumed the plea for the defendant at the opening of the afternoon session at 2 o'clock. He was followed by Attorney W. T. Vaughn, specially retained by the Whitney family to assist in the prosecution. They concluded their arguments shortly after 2 g'elock.

Mary Murray, sister of the young man whose fate is in the hands of the jury, was conspicuous today by her absence from the courtroom. At the conclusion of her testimony yesterday she fainted and suffered an attack of hysteria. She is said to be seriously ill as a result of her trying ordeal. The plan of the defense to place the defendant himself upon the stand was changed and he was not given the opportunity to tell his story.

It is expected that a verdict will be returned by the jury early this evening.
