### **BIOGRAPHY OF ELLIOTT, FRANK**

Elliott runs a fish market in Tillamook. nterviewed him recently, he said:

born in Milwaukie, about midway between 1 and Oregon City on June 25, 1855. My rossed the plains to Oregon in 1847. My faame was Francis Marion Elliott. He was born York state. My mother, whose maiden name elia M. Cutting, was born in Indiana. There of us children. My sister Mrs. Hattie DeVine ears old. She lives east of Portland, on the Gresham. My sister, Mrs. Henry Ruhl lives nam. My brother, E. P. Elliott lives at Oregon y brother, George W. Elliott, who died recentolder than me. When he was a boy he was y. Later he worked on Knott's Ferry, which the Willamette River at Stark Street. At that e ferry was run by mule power. My mother's Charles Cutting, was in the same wagon train folks when they crossed the plains in 1847. ather Cutting settled on Milk Creek. He ran mill there and a blacksmith shop. Later he hotel and a store. They called the settlement sville, though now it is known as Molalla. n gold was discovered in California, my father own there and for quite a spell ran a tavern amento. When he came back, along about

e family lived at Milwaukie, where I was born. ther took up a place on the 'Big Burn' about iles east of Portland, on the road to Gresham. rted to School in East Portland in 1862. When even, our family kind of broke up, so I went vith my sister, Mrs. Charles Devine. Her husas a bricklayer who lived in East Portland. was 14 years old I went down to Oak Point ked for R. D. Hume & Cook's salmon cannery. vere only two canneries on the river in those ill Hume had one and R. D. Hume the other. aid 25¢ each for salmon. After about a year back to Portland and worked for my brother-Charles Devine, as offbearer in his brickyard. carried a hod. I carried the brick for the first ailding in East Portland. Charles and Dave Rafferty started a drug store in East Portland in 1869. A year or two later they built a two-story brick building and I carried the hod for this building. They came to Portland in 1852. Their father's name was Sam Rafferty. Sarah Rafferty married W. P. Miller and Emma married Albert Wirtz.

"The first time I came to Tillamook was in 1871. I worked here a while and then went back to Portland and worked as a hod-carrier. My brother-in-law, Charlie Devine, in addition to running a brickyard, worked as foreman for E. J. Jeffries, who was a contractor and built many of the early-day buildings in Portland. I carried Brick when they built the Bank of British Columbia on Front Street and also on many other buildings on First and Front Streets.

"After carrying brick for three years, I came to the conclusion that it was a whole lot like work, so I went to Astoria and did salmon fishing for the next five years. We were getting 25¢ each for our salmon, so the fishermen's union selected me as one of the committee to notify the salmon canneries that they would have to pay us 50¢ a piece for salmon. We gave them our notice on April 1. They thought they could wear us out, so we didn't turn in a salmon from then till May 28, when they gave in and agreed to pay 50¢ apiece for salmon. I worked for just two months, from May 28 to July 28, and when I drew my third, I had over \$1400.00. The cannery, which furnished the boat and net, got one third, my boatpuller got a third, and I got a third. The river was alive with fish. There were so many that the cannery would only accept one delivery a day. We would load our boat with all it would hold and make our one delivery. We would usually take in from 130 to 150 salmon. They ran from 20 to 40 pounds in weight. Later I furnished my own gear - boat and net so I was paid 60¢ for each salmon I caught.

"On the 8th of May, 1875, we had the worst storm that I have ever seen. I took shelter under the lee of some rocks on the Washington side and weathered the storm. Next morning I saw 14 dead fishermen picked up on Chinook beach. The fishermen who

CHARLES CUTTING. Charles Cutting, one of the unique pioneer characters of Clackamas county, died at the home of O. Dickson on the Abernethy, last Sunday night aged about 67. The interment was in the Redland cemetery Monday. Only four persons were passent at the funeral except the undertaker and hearse driver Mr. Cutting had been a resident of Clackamas county for over a half century, and located the Cutting donation land claim at Meadowbrook, which has long since passed into other hands. He at one fime published a book on some abstruse topic. He was in destitute circumstances during the past few years, and put in considerable of his time prospecting in the mountains. Cutting, of Molalla, is a distant relative of the deceased.
