PIONEER OF 1847 BURIED.—Abel Cutting, who died March 17 at the home of Mr. and Mrs. Edward Luce at Prairie City, Or., was a pioneer of 1847. During his younger days Mr. Cutting was known as a great hunter and trapper. He was buried at Inzee, Or., where he had spent a greater part of his life. He was born April 28, 1844 in Indiana and crossed the plains with his parents by ox team. His father took up a donation land claim at Redland, Or. He is survived by two sons, William and Fred Cutting.

"Oren Cutting, a prosperous farmer of Clackamas county, Oregon, was born at Park Place, in this county, October 14, 1847, son of David and Mary (Mattoon) Cutting, natives of Indiana. His father was born November 11, 1814, and his mother May 6, 1821, and they were married November 11, 1838, in their native State, and had three children born to them there. In the spring of 1847 the family left their Indiana home and started across the plains for Oregon, and in due time reached their destination. Abel Cutting, the only one of their three children who is now living, is a resident of Grant county. While on their journey across the plains the father had the misfortune to be bitten with some insect, which bite resulted in a sore and scar that badly disfigured his face.

It was, however, bidden by a heavy beard, The following spring, 1848, he took as his donation claim a section of timber land located nine miles east of Oregon City. To the clearing and improving of this land devoted his every energy, working early and late, and from his pioneer home hospitality was extended to all, both friend and stranger meeting with a cordial welcome, he and his good wife had the respect and esteem of all who knew them. His death occurred in 1868 and his wife's December 14. 1880. Of the five children born to them in Oregon, we make the following record: Oren, the subject of this sketch, is the oldest. The second born died in infancy. Eliza became the wife of George Hicinbotham, and they reside on the old home place, Charles is settled nearby; and David is married and resides in Grant county, this State.

Oren Cutting was reared on his father's farm, and by home study and attendance at the little log school house nearby he gained his education. After his father's death he took charge of the farm. He inherited 300 acres of it, the part which belonged to his mother, and she lived with him up to the time of her death. Later he went to Molalla and purchased the donation claim of Grandfather Cutting 640 acres. In company with his brother, David, he farmed this property four years. He finally sold out and went to Grant county, where for five years he was engaged in the stock business. He then retired to the home farm and on it has since resided.

March 8, 1888, he was married to Miss Virginia Vaughan, a native of Clackamas county, and the daughter of W. H. Vaughan, an Oregon, pioneer of 1848. Mr. and Mrs. Cutting have two children: Allen T., born December 17, 1889; and Susan Mary, born August 18, 1892.

Like his father before him, Mr. Cutting is in politics a Democrat. He has served as Road Supervisor and School Director in his district for a number of years.

On the Cutting homestead is a walnut tree which measures fifty-four inches around the trunk, and the branches of which afford an inviting shade. The nut from which this tree grew was brought here from the East and was planted by the father of our subject. It gives good evidence of the productive soil in which it grows, and stands as a monument to the worthy pioneer who planted it." [Illustrated History of the State of Oregon by H.K. Hines, p. 1007]

### Cut With Ax Farmer May Die.

OREGON CITY, Or., Feb. 11.—Allie Cutting, son of Oren Cutting, a well-known farmer of Molalla, met with a painful accident last week, which will probably cost him his life. The young man had gone to Eastern Oregon to work, and while cutting fence rails with young Robbins, son of Willard Robbins, the ax slipped from the hands of Robbins and almost severed Cutting's foot. The young man was hurriedly taken to Canyon City for medical treatment, but before reaching that place he had almost bled to death and his life was despaired of for some time. Word reached his parents at Molalla yesterday that blood poisoning had set in.

"DAVID CUTTING Among the dairymen of the vicinity of Tranquillity, Fresno County, particular mention is made of David Cutting, a pioneer citizen of the Pacific Coast Country having first seen the light of day November 19, 1849, at Oregon City, Ore.

His father, who bore the same name, was a native of South Bend, Ind., while his grandfather, Charles Cutting, was born in Vermont and saw service during the War of 1812. David Cutting Sr. was married in Indiana to Mary Matoon, a native of the Hoosier State. In 1847 Mr. and Mrs. David Cutting Sr., with their family, consisting at that time of but two children, crossed the plains with the slow going ox teams to Oregon where they engaged in farming. They were the parents of six children: Jones, Abel, David, Charles, Oren, and Eliza; three of whom, Junes. Charles and Eliza are deceased. Abel lives with his brother David, while Oren resides in Clackamas County, Ore.

David Cutting was reared and educated in Oregon and on August 16, 1877, was united in marriage with Miss Mary F. Zamette, a native of Portland, Ore., daughter of Achilles and Rachel (Mognette) Zamette. Her father, a native of Palermo, Sicily, became a sailor and on one of his voyages came to California, via Cape Horn, later going on to Portland, Ore., where he became a merchant. Her mother, a native of Ohio, became one of the early settlers of Oregon and passed away in Portland.

In 1883 David Cutting located in eastern Oregon, which at that time was a wilderness, preempted 160 acres, bought school land and homesteaded 160 and engaged in raising cattle, horses and sheep, using as his brand a big W., and having at one time 800 acres of land.

In 1909 David Cutting made his first trip to California and after investigating the country round about Tranquillity, Fresno County, he decided this would be the location of his future home. In April, 1910, Mr. Cutting purchased his ranch consisting of 171 acres of raw land at Tranquillity, subsequently selling his farm in Oregon, he located in October of the same year, upon his new place in California. He at once began to improve the land by leveling, checking and planting 100 acres to alfalfa and grain, and engaged in the dairy business.

Mr. and Mrs. Cutting have six children living: Flora, is the wife of Mr. J. H. Stricklin, residing at Tranquillity; Harry, lives at Izee, Ore.; Paul, was a sergeant and a member of the medical corps in United States Army. served five months in France ; Clarence, is assisting his father with the work of the ranch ; Anna, is still at home with her parents ; Rodney, also is assisting his father on the ranch. Two children have passed away: George was killed by the Indians when nineteen years old, and Jones died at seven years of age. In political matters Mr. Cutting supports the Republican platform." ## DAVID CUTTING, 87, DIES AT TRANQUILITY, CAL.

David Cutting, 87, ex-resident of Clackamas county, died recently at his home in Tranquillity, Cal., friends and relatives here were notified.

When a young man, Cutting and his brothers, Oren and Charles, owned and operated a farm at Molalla. The farm now is owned by State Treasurer Rufus C. Holman. Their parents, David and Mary Cutting, crossed the plains by ox team in 1847.

In 1910 David Cutting moved to California, where he engaged in dairying and general farming.

He is survived by two daughters, Miss Anna Cutting and Mrs. Flora Forsythe, and three sons, Harry, Clarence and Rodney Cutting, all of Tranquillity. Nephews and nieces residing here are Allan and Hugh Cutting and Mrs. Mamie Baty of Molalla; Mrs. Lydia Officer, Mrs. Rose Gianini and Mrs. Annie I. Hughes of Redlands, and Charles Hicinbotham of Estacada. A cousin, Ernest P. Elliott, resides at Oregon City.
