*“Jackson lost all but one steer. James Gilbreath lost all his teams except 1 cow and 4 steers so we left 2 of our wagons and every other thing that we possibly could do without and went on in 1 wagon. Before we left our wagons Craig and his wife died. Craig died 4 days after his wife. It seemed as if everything was against us. It seemed as if nothing but lying by would satisfy some of the company. Before Craig's death, David Harer had cut up several of his tyrannical scalops. Afterwards he was ten times worse if possible in as much he had several loose cattle running loose and knowing that we was short of teams he became very abrupt and insulting thinking that our circumstances would not admit of retaliating or leaving their company.*

*He didn't know that it was only on Craig's account that we stayed and poked along with that aggravating and insulting man and others that are dead whom I shall not mention. Things went on in this kind of style several days. David has been appointed of camp muster and became so overbearing that the boys was very much displeased with him as captain so we elected Craig.”*

Oregon Pioneer of 1852 Is Called By Death--The Late W. Claiborne Richardson, a native of Iowa and a pioneer of 1852, aged 73 years, 10 months and 3 days, died in this city yesterday. Mr. Richardson was born in Iowa, January 8, 1835, and with his parents, crossed the plains to Oregon in 1852, residing for a short time in Polk County, and afterwards locating in Lane County. He was a resident of Portland from 1862 until 1871, and two years later removed to Independence, where he lived until last Spring, when he

returned to this city to live with his daughters. He is survived by a widow, two sons and three daughters. His sons are Judge William E. Richardson of Spokane, Wash., and Frank Richardson, Deputy Sheriff, Solomonville, Ariz. His daughters are: Mrs. May Farley, Mrs. Jennie Hutchins and Miss Effie Richardson, all of this city. The remains will be taken to Dallas, Polk County, for interment. [The Oregonian, Portland, Oregon, November 12, 1908]

**JOHN B. GOODMAN**—A well-to-do resident of the Belknap Settlement is a native of Cooper county, Missouri, born March 15, 1834, and resided in his native county until spring of 1852, when he, with his brother J. H., joined a train and came across the plains to Oregon, arriving in Salem, September 15th of that year. Two years later our subject came to Benton county and took up a donation claim, now owned by Mr. Nichols. In 1881 Mr. Goodman purchased his present valuable farm of 238 acres, located four miles west of Monroe, where he is engaged in general farming and stock raising.

### John B. Goodman.

ALBANY, Or., May 10.—(Special).—John B. Goodman, 93, a native of Casper county, Missouri, and an Oregon pioneer of 1852, crossing the plains by ox team, died at the Albany General hospital. He was born March 15, 1834. Arriving in Oregon he settled with his parents near Scio, and a few years later moved to Benton county, where he spent the major part of his life. He purchased a farm near Monroe in 1881, lived there for a few years before going to Corvallis. Two years ago he came to Albany. He lived with his daughter, Mrs. Frank Kamph, and his son, Bert Goodman, until his last illness. In 1855 he was married to Sarah E. Craig, who died many years ago. Four children survive: Mrs. Frank Kamph, and George and Bert Goodman of Albany, and Charles Goodman of Pendleton. Funeral services were held today at Alpine, and interment was made there.

From the Probate Journal, No.1, 1852-1859, Lane County Oregon:

p.39: David Harer Guardian of Craig's heirs filing an inventory of the funds in his hands belonging to Hetty A. and Sarah E. Craig minors and orphans of E P Craig (decd) which amount is Five hundred and forty-one dollars and eighty cents \$541.80 and the Court ordered that the Guardian loan the same out, on good security at 12 1/2 per cent interest. Court adjourned, this 4th day of Sept, 1855 at Eugene City.

p.46: At the December 4th meeting, David Harer became the guardian of John Wm. Craig, orphan of EP Craig deceased, being 11 years old, whose former Guardian had lived in Benton County.

p. 77: And now comes David Harer Guardian of the Estate of Hetty A. Craig and Sarah E. Craig and presents his accounts for allowance as such Guardian and presents the following claims against said Hetty A. Craig and Sarah E. Craig which are allowed by the Court after having been sworn to by said David Harer
