Lebanon, Or., Aug. 22.—Mrs. Ann M. Smith, pioneer, of this city, died at her home last Sunday morning at the age of 65 years. Although she had been in poor health for a year, her leath was unexpected, and was the result of heart trouble.

MRS. SARAH CLAYPOOL DEAD.

Prominent Pioneer Woman of Lebanon Ended Her Life Work Saturday.

Mrs. Sarah Claypool, Oregor pioneer of 1853 and resident of Linn County for half a century, died at the family home near Lebanon last Saturday. The funeral was held yesterday.

Mrs. Claypool was a native of Missouri and was 67 years old. She crossed the plains to Oregon in 1853 and was married in 1862. There were four children in the family, all girls, three of whom are married. The deceased left many friends throughout the country, especially among the ploneers, by whom she will long be remembered.

Death of S. R. Claypool,

Hon. S. R. Claypool died at Lebanon yesterday morning. and Linn county loses a worthy citizen, one prominent in the unbuilding of the county.

He was born Aug. 28, 1836, in Indiana, and crossed the plains with his folks in 1846, first settling in Clackamas county, in 1848 coming to Linn county, afterwards his home. He was in the Indian wars of 1856, mined in California a couple of years. In 1865 he bought a farm near Lebanon, which he run until five or six years 2go, when he moved to Lebanon. He was county commissioner for four years, 1886-90, was a member of the legislature in 1893, and was a school director for many years.
