NEARLY A HUNDRED -Mr John Crab tree, who died on the 29th of March, was a remarkable old man. He was born in Lee county, Va, on June 20th, 1800, in which state he was married on February 22nd, 1825, to the woman who survives him, at the age of 85 years. They had five children in old Virginia; from there they went to Missouri and had five more children; thence to Oregon in 1845, where they had five more children, fifteen Sometimes Mr Crabtree jokingly proposed to go to California Ito see if the record would be continued. They stopped in Yamhill county; but moved to Linn county in 1846 and took up the donation land claim on which Mr Crabtree afterwards lived and died. Nine children besides a faithful wife, survive him. deceased had been remarkably strong for his age until five or six months ago, when he began failing purely from old age. A long life, well spent is the record left. Mr Crabtree was buried in the Masonic cemetery near his home.

Early in life her parents moved to Virginia and remained there until she was grown, married and the mother of five chi.dren. After that with her husband and family, they settled in Miscouri, Jackson Co, staying there until the family increased to ten. In 1845, with her husband and family, she crossed the plains in an ox wagon to Oregon, and settled on the place where she died in 1846. Five children were born to them in Oregon.

A few months before she died she was paralyzed and never spoke after that, She died in peace. She was a staunch member of the M. E. church South over seventy years.

Death a Result of Being Kicked by a Horse.

Jas. P. Crabtree, better known as "Tinker Jim" Crabtree, died at 1 o'clock Monday morning at his home at Crabtree, from the effects of a kick of a horse Friday afternoon. He was with the horse in front of Turnidge's store, when the animal did the kicking, striking him in the stomach, causing fatal internal injuries. The deceased was a son-in-law of B. Burtenshaw of this city. He was a wellknown and highly-respected citizen. He leaves a wife and five children, one son, John, four daughters, Mrs. J. W. Yonug, Mrs. David Horsburg, Mrs. Earnest Titus and Miss Rose Crabtree, all of this county.

Mr. Crabtree was a native of Missouri, 71 years old, and came to Oregon in the 40's, his father being one of the first settlers in Linn county. He lived near the vicinity of his old home for more than half a century.

SCIO PIONEER WOMAN DIES AT AGE OF 90

Scio —Mrs. Elizabeth Gaines, 90, wife of Sam Gaines, died at the farm home south of here Tuesday morning. She was one of the oldest residents of the Oregon country, coming to the state with her parents, Mr. and Mrs. John G. Crabtree, in 1845, four years before Oregon became a territory.

Elizabeth Crabtree was born in Missouri July 17, 1840. Five years later the family, which included several other children, crossed the plains by ox team and spent the first year on the Tualatin plains. The next year they moved to Crabtree creek where John Crabtree took up a donation land claim. The stream and the small The stream town of Crabtree were named after the family. There were, in all. 15 sons and daughters of John G. Crabtree and his wife. Two of them, Mrs. Rebecca (Aunt Becky) Morris of Scio, Queen Mother of Linn county pioneers, and Mrs. Phoebe Turner of Crabtree survive.

As a young woman she married Mr. Griffin, and seven children were born to the union, all of whom survive. Following the death of Mr. Griffin, she married Sam Gaines. The surviving children, in addition to her husband, include two daughters, Mrs. Belle Archer of Scio, and Mrs. Clarence Lovejoy of Salem; and five sons, George Griffin, John, Jack, and Clifford, all of Scio, and Elmer Griffin of Salem. Other distant relatives live in Wasco county near Maupin.

Mrs. Gaines was a member of the Baptist church of Scio. Funeral arrangements had not been completed Tuesday.

NEWTON CRABTREE RECALLS INCIDENT OF LONG AGO

Aged Linn County PioneerHiked 16 Miles This Merning Without Lift.

Forty-nine years ago today occurred the hanging in this city of Andrew J. Pate, a convicted murderer, before a vast multitude of early residents of this section, according to a statement made this morning by Newton Crabtree, an old pioneer of Linn county who has reached the ripe old age of 70, and who resides six miles east of Crabtree. On this occasion, stated Mr. Crabtree, who appears hale and vigorous at his extreme age, he made his first trip to Albany, accompanied by his father and a twin brother. He said that as near as he could recollect the hang-ing took place on Fifth avenue in the neighborhood of Calapooia street but his rememberance appeared to be very vague relative to the incidents attendant to the case. The hanging was conducted by the state under a law which required that such punishment should take place in the territory in which the crime was committed.

Aside from the above incident of the hanging a peculiar incident hap-pened to Mr. Crabtree this morning. Setting out from his home 16 miles from here early this morning to walk to Albany in full anticipation of a lift from a passing wagon, over a road that has about the heaviest travel of any highway out of the city and to cover the whole distance on foot without meeting a vehicle bound for the city seems hardy credible, but nevertheless it happened to Mr. Crabtree this morning, who arrived here at 9 o'clock dusty and slightly weary after his long journey but ap-pearing to be none the worse for the wholesome exercise. An erand of business with Mr. Fred Dawson of the Owl drug store, brought Mr. Crabtree to Albany this morning. He will probably spend the night here with relatives and will return home tomorrow.

SCIO PIONEER CROSSES DIVIDE

Scio, Ore. —Newton "Uncle Newt" Crabtree, 84, pioneer resident of Crabtree creek and Scio, died here Thursday morning after an illness of nearly two years. He suffered a second paralytic stroke a few days ago which was the immediate cause of death.

Newton Crabtree was born on the Old Oregon trail skirting the Columbia river near the present site of The Dalles in 1845. He was the son of Mr. and Mrs. Andrew Crabtree, who were enroute from Missouri by ox-team at the time. A twin brother, Jasper, died at the age of 25 years.

The Crabtree family, upon the convalescence of the mother, pushed on to the Tualitin valley, where they spent the inter of 1845-46, and then came to the Scio district where they settled on Crabtree creek, on a donation land claim. They built the first cabin in this part of the state.

Descendants of the original Crabtree family, Andrew and his brother, are now scattered in many parts of Oregon.

Three sisters are the immediate surviving relatives of Newton Crabtree, including Mrs. Rebecca Morris, and Mrs. Sam Gaines, both of Scio, and Mrs. Phoebe Turner of Crabtree.

Funeral services were held Friday at 1:30 p. m. from the Scio Christian church. Interment was in Franklin Butte cemetery, where members of the Scio I. O. O. F. lodge held graveside services, Crabtree had been a member of the Scio lodge for the past 49 years.

EARLY SETTLER OF COUNTY PASSES AT AGE OF 84

Newton Crabtree, 84, native of Oregon, who was born on the banks of the Columbia river while his parents were en route to their pioneer home in the Tualatin valley, died at the home of his daughter, Mrs. Arthur Lettenmaier, at Crabtree, last Thursday of paralysis.

Mr. Crabtree was born in October, 1845. His parents came to Linn county in April, 1846, from the Tualatin country, taking up a donation land claim in the vicinity of the present town of Crabtree, which was named for the family. Newton Crabtree lived on this claim all his life. He was one of a set of twins, his twin brother, Jasper, dying when 25 years old.

Surviving are three sisters and the daughter. The sisters are Mrs. Rebecca (Aunt Becky) Morris, Scio; and Mrs. Phoebe Turner, Crabtree.

The funeral was held at the Scio Christian church Friday afternoon. Services at the grave were conducted by the Scio I. O. O. F. lodge, of which Mr. Crabtree had been a member for 49 years.

NEWTON CRABTREE.

Newton Crabtree, an honored pioneer of Oregon and a representative of one of its oldest families, his parents having arrived in this state in 1845, is now engaged in cultivating a tract of fifty acres of rich and arable land three miles south of Scio. He was born near The Dalles, Oregon, October 22, 1845, and is a son of John J. and Melinda (Yeary) Crabtree, the former a native of Virginia and the latter of Kentucky. At an early day the father went to Missouri, where he resided for about five years, and in 1845 he started from Independence, that state, for Oregon, traveling with ox teams and wagons. The party set out on their journey in May and it was not until November that they arrived in Vancouver, Washington. Upon their arrival at The Dalles they constructed a raft, upon which they placed their seven wagons, and in that manner proceeded down the Columbia river to Vancouver. They spent the winter in Yamhill county, Oregon, and in the following spring made their way to Linn county, where the father took up a donation land claim. He at once set about the arduous task of clearing and developing his land and after many years of persistent and unremitting labor he succeeded in bringing his farm to a high state of productivity, becoming the owner of a most valuable property. He was one of the real builders of the west, who bravely endured all the hardships and privations of frontier life and aided in laying broad and deep the foundation upon which has been built the present progress and prosperity of the country. He became a man of prominence in his community and it was in his honor that the town of Crabtree was subsequently named. He reared a family of fifteen children, five of whom were born in Virginia, five in Missourl and five in Oregon, and six of his sons participated in the Washington and Rogue River Indian wars. The twin brother of the subject of this review was Jasper Crabtree, who died about 1890. The father passed away on the 28th of March, 1892, at the venerable age of ninety-two years, while the mother survived him for six years, her demise occurring in 1898, when she had reached the advanced age of ninety years. They were truly cast in heroic mold. Braving the dangers of the unknown west they courageously faced the hardships and privations of that long and arduous journey, devoting their lives to the redemption of the Pacific coast region and counting no sacrifice too great that was made for the benefit of their home locality.

Newton Crabtree was reared and educated in Linn county and has here spent his life. He attended district school, the schoolhouse being a log cabin, for the country was then wild and undeveloped and the Indians far outnumbered the white settlers. On reaching mature years he took up the occupation of farming, cultivating a tract of land which his father had given him. This he further improved and developed and subsequently purchased additional land, but later disposed of the greater portion of his holdings, retaining fifty acres, which he is now operating. He has ever followed the most progressive methods in the cultivation of the soil and his unabating energy and well directed efforts have won for him a substantial measure of success. His land is rich and productive and its value is much enhanced by a small stream which runs through the farm and which was named Crabtree creek in honor of his father.

In October, 1871, Mr. Crabtree was united in marriage to Miss Frances Wilson and they became the parents of five children: Fred, who died November 26, 1894; Nellie, whose demise occurred on the 4th of March, 1906; Maggie, who is the wife of Frank Sommer, a farmer of Linn county; Flo, who married C. C. Smlth and resides in Portland, Oregon; and May, the wife of Arthur Lettenmaier of Oregon City. The wife and mother died November 16, 1915, after an illness of six months, and on the 9th of February, 1920, Mr. Crabtree was married to Emma Bann.

In his political views Mr. Crabtree is a democrat and he has taken an active part in public affairs of his community, serving for many years as a member of the school board, while for a quarter of a century he acted as clerk of that body. Fraternally

he is identified with the Indepedent Order of Odd Fellows, which order he joined on the 3d of November, 1880, and his religious faith is indicated by his membership in the Methodist Episcopal church. He is a member of the Oregon Pioneers Society and is one of the oldest residents of the state, having spent the entire period of his life, covering seventy-five years, within its borders. He remembers when the country was wild and undeveloped, with only a few scattered dwellings to show that the seeds of civilization had been planted. The passing years have brought their influx of settlers, and with interest he has watched changing events and in considerable measure has contributed to the development of the community, his aid and influence being ever on the side of progress and improvement. He has led a busy, active and useful life and is widely known and universally honored.


LINN NATIVE DIES AT RESIDENCE OF SON NEAR LACOMB LEBANON, Jan. 2. (Special)—Mrs.

SEVEN SURVIVING MEMBERS OF PIONEER LINN COUNTY FAMILY GATHER IN HISTORIC REUNION.

ALBANY, Or., Nov. 10.—(Special.)—For the first time in 49 years the seven surviving members of Linn County's oldest pioneer family were all together while attending the Linn County Fair at Scio recently.

The last time all of these brothers and sisters were together prior to this meeting was at Mrs. Morris' wedding in 1862. All now live comparatively close together, but until shortly prior to this reunion Job Crabtree and Isaac Crabtree have lived in Montana for 44 years and had not been in Oregon during all of that time.

All are children of Mr. and Mrs. John J. Crabtree, who settled in Linn County in 1845, after crossing the plains to Oregon from Missouri. Their family, while not the first to settle within the boundaries of Linn County, came here earlier than any other family which established a permanent residence in this county, and has the additional distinction of having lived for many years in the first house ever built in Linn County. This house was erected in 1844 by John Packwood, three miles south of the present town of Scio. Packwood stopped in the house only a short time and Crabtree took up the original donation land claim on which the house was situated. This old house stood until only a few years ago.

There were 15 children in this historic pioneer family. Five of them were born in Virginia, five in Missouri and five in Oregon of these new living. Newton Crabtree, Mrs. Smith and Mrs. Turner were born in this state, and the former is one of Linn Countr's eldest living native sons. Mrs. Morris was the

youngest of the children bur " Missouri and was a baby when the family crossed the plains.

John J. Crabtree was born in the year 1900 in Lee county Virginia, when John J. was 25 years of age he commenced farming for himself. In 1825 he married Miss Milinda Yeary.

After marriage Mr. Crabtree went to work with a will to get a home and he succeeded well. He remained for 8 years on this farm, when he sold out and moved to Missouri.

After remaining 8 years in Missouri, owing to sickness and other unfavorable circumstances, his progress was slow.

He became convinced that better chances were awaiting him on the Pacific slope. He started for Oregon in 1845, his outfit consisting of ox teams. The trip was of course at this early date a very difficult one, there being no beaten road to travel. After many hardships he arrived at The Dalles in October, where he built a raft in which to descend the Columbia.

While building the raft Mr. Crabtree's family was increased by the advent of twin boys, probably the first event of that kind among the white settlers of Oregon. They were named Jasper and Newton.

Without fear and with great courage he embarked on the river voyage.

Mr. Crabtree wintered in the Tualatin plains. In the spring of 1846 he started to locate a home. While traveling up the valley he found a man living in a log cabin, by the name of John Packwood, who had built his cabin in 1844 on a stream of water now known as the Crabtree river in Linn county.

It was traded to John J. Crabtree in 1846. It still stands on its original foundation of oak blocks which are in a remarkable state of preservation.

This cabin was used by Mr. Crabtree for many years as a home and is now used for a hay barn.

Fifteen children were born to Mr. and Mrs. Crabtree. Five in Virginia, five in Missouri, five in Oregon. Nine of these children are still living.

PIONEERS HAVE REUNION

Crabtree Family Meets at Home of Oldest Native Son.

ALBANY, Or., June 12.-(Special.)-Three sisters and a brother, all more than 80 years old, were present Sunday at a family reunion held at the Newton Crabtree farm near Scio. Present were 100 descendants of John J. Crabtree, father of the four who featured the reunion, and a pioneer of 1845.

Newton Crabtree was born when his parents arrived on the banks of

the Columbia river on their way to Linn county, and is said to be now the oldest native son living in Oregon. He and his three living sisters are the surviving members of a family of 15 children. The sisters are Mrs. S. W. Gaines, 87, living near Scio; Mrs. Rebecca Morris, 85, Scio, and Mrs. Fhoebe Turner, Crabtree.

The present Crabtree farm is part of the claim which the father of the four received from the government in 1846. The two older women were

born in Missouri.

At the reunion were residents of Portland, The Dalles, Maupin, Marshfield, Independence, Salem and the Scio community.

Reunion of Crabtree Clar Held on Historic Ground

Descendants of John J. Crabires who took the first donation land claim in Linn county, from all parts of Ore gon, gathered at the historic place three miles south and west of Scio Sunday for their annual reunion From Portland to Coos Bay and from all parts of western and central Ore gon they flocked to visit the spot of such vital interest to themselves and to pay tribute to the memory of the sturdy pioneer who left Missouri in 1845, reached the Columbia early the next year and later in the year filed on the claim near Scio.

A bountiful basket dinner was served on the place at noon, after which Senator Willard L. Marks of Albany delivered the address of the day, is which he revered the memory of Mr Crabtree and called attention to the many virtues and achievements of his descendants. Frank L. Smith, Lebanon, was the chairman of the day.

Great interest centered around four living children of John J. Crabtree, all of whom are living on or not far from the chaim and all of whom are past 80 years of age. These were Mrs. S. W. Gaines, 88, of Scio; Mrs. Rebecca Morris, 86, Scio; Newton Crabtree, 83, who resides on the original donation claim, and Mrs. Phoebe Turner, 81, Crabtree. Mrs. Gaines and Mrs. Morris were born in Missouri but Newton Crabtree was born on the Columbia river as the family approached its destination. Mrs. Turner was born on the claim.

Timbers that were squared to build the original house are still in existence, being now a part of any outbuilding on the farm. Many of the visitors viewed them with great interest.

One of the interesting disclosures was the statement that Linn county's first Fourth of July celebration was held near the Crabtree claim. The date of the fete was 1850. Mrs. Galges and Mrs. Morris remembered it well and their testimony was corroborated by Haman Shelton, of Lyons, who is 90 years old and was present at the celebration. Mr. Shelton is connected with the Crabtree family by marriage.

Mrs. Turner, who was born on the claim in 1848, is the oldest living native daughter of Linn county, now living in the county, and Newton Crabtee, who was born on the Columbia river while the family was en route to Oregon, is the oldest native born Dregonian in Linn county.

Marion Crabtree, now deceased, a prother of the four octogenerations, was the first native born son of Linn county.

Crabtree creek and the present town of Crabtree are named after the famly.—Democrat-Herald.
