### Confusion/Problems/Disclaimers by Danelle (Dani) Mann:

An article that was published in 1932 called Bits for Breakfast has been the cause of a lot of misinformation. Adams researchers use Susannah March as the mother. She was the wife of Charles Hinkle. Another family, the Tuckers, claims Rebecca is the daughter of Aaron Tucker and his wife Nancy Haggins, who ran away with Michael Hinkle. Rev. Anthony Jacob Hinkle, a Lutheran minister who came to Germantown, Pennsylvania in 1717. Most of his children were christened at the Evangelical Lutheran Church in Daudenzell, Germany. He had been ordained in Germany and had served 25 years as a pastor with various congregations in the upper east Heidelberg. He was probably responsible for organizing the first Lutheran congregations in Pennsylvania. He lived at Falckner's Swamp in today's Montgomery Co, Pennsylvania and served the German communities throughout present-day Philadelphia and Montgomery Counties. DNA taken from the brothers of Rebecca, George March Hinkle and William Hinkle prove they are both descended from Rev. Anthony Jacob Hinkle.

DNA testing for Kevin Adams (descendant of John Franklin Adams through Jesse Luster Adams) proves that this line is descended from a long line of North Carolina Adams; the DNA does NOT MATCH the Presidents Adams DNA line. Refer to Family Tree Adams DNA project Line 23.

Another misconception is the Samuel Whitley connection. There is none. He was not related as far as I have found. His family originated from Paul Whitley/Jane Kirkham, originally from Ireland and who came to America sometime in the 1700s. James Willis Whitley is a descendent of John Whitley/Ann Moss who were in the Isle of Wight Co, Virginia since the early 1600s. James Willis Whitley's grandfather, William, left Virginia and was in Ohio in 1820. In 1830 and 1840 census, he was in Indiana. By 1850 he was in Iowa. His father was in the 1820 Census in Bath, Greene Co, Ohio census listed as a farmer. Samuel and James Willis Whitley and John F. and Rebecca Adams were neighbors and did know each other and interact with each other. Samuel was from the Church of Christ. John F. and Rebecca Adams, as well as James Willis Whitley were early members of the Mormon Church. Rebecca's brother was the famous or infamous George M. Hinkle, an early leader in the Mormon Church who converted not only Rebecca and John, but John's brother Jesse Luster Adams early in the 1830s.

Rebecca Hinkle Adams' obituary, recorded in The Saints' Herald, Volume 24, Page 287 states, Near Salem, Marion County, Oregon, July 20th, 1877, Sister Rebecca Adams, wife of Elder John F. Adams, and only sister of the late G.M. (George M.) Hinkle. She was born in Roan county, N. C. August 18th, 1804, consequently, was at her death in her seventy-fourth year. She was married to Bro. John F. Adams in 1820, and in 1832 they were both united to Christ and his Church, by obedience to the everlasting gospel, from which time to the day of her death Sr. Adams has been an exemplary Christian, and for the last two years a patient sufferer. For forty-five years she stood as a witness for Christ, and many are the testimonies she has borne, and the times that she has exercised the gifts in fulfillment of the promise of the Master (Mark 16). She leaves behind children, grand-children, and great grand-children to the number of a hundred and twenty-five. Father Adams is blind, as to his natural vision, and his inner eyes are open to see the glory of the coming kingdom for which he has waited and labored so long. He bears with Christian fortitude his sad bereavement, and consoles himself with the fact that he, too, has been redeemed by the blood of Christ, and a few more days or weeks and he will be again united to his faithful partner, where the tyrant death can have no power over them. For fifty-seven years they stood together to share each others joy or sorrows, and together they stood the storms of persecution that have been common to the Saints. And now, while the ashes of our dear sister shall rest in peace, may the sympathy of the Saints be enlisted in behalf of the good old brother, that he may "accomplish his day" in peace, and with his dear companion hail, at his coming, the king that they have so long and faithfully served. #### "ABRAHAM SARGENT DEAD--

"Abraham Sargent dropped dead Tuesday, the 12, at noon while walking out in the yard of his son Oliver, where he has lately been residing. Heart trouble was the cause of his death. He will be buried today (Thursday) on Deer Creek. Mr. Sargent lived in this county for many years, though the past year or two was spent in Coos county, returning to Selma recently. He was a veteran of the Modoc war, because of which he was drawing a pension of \$12 per month at his death." [Rogue River Courier-Grants Pass, Oregon--Thursday, July 14, 1898 per Jim Cook]

Notes from Jim Cook: There are several mistakes in published information for this family: The Sargent and Wagner families started out with the 1852 group from Grandview. Somewhere they diverted to Salt Lake City and spent the winter there. They then went on to El Dorado County, California, in 1853. In about 1858 they finally continued on to Oregon. The Wagner Family settled for a short time in Jackson County. Isaac M. Wagner had an older brother, Jacob, that had settled there, Ashland, in 1850. The Sargent Family continued on to Marion County, which is where the Adams Family had settled in 1852. Jacob, by the way, went back to Iowa in 1851, married, and returned to Jackson County, Talent, and filed a DLC in 1853.

I do not think that Abraham served in the Modoc Indian War, as stated in his obituary. I have a copy of his pension record and it does not list service at that time. His service was in Company I of the 1st Oregon Volunteer Infantry. This was a Civil War Unit in service from 1865 to 1867. Company I served most of its time at Fort Klamath and building a new road between there and Grants Pass. Abraham enlisted Jan 9, 1865 and was discharged due to injury on Aug 20, 1866. The Modoc Indian war was 1872-1873. Abraham served with three of his sons; John, Reason, and Oliver. [per Jim Cook]



OLIVER SARGENT, deceased, was one of the early pioneers of Oregon. He was born in Iowa, August 4, 1849, and was the son of Abram and Nancy (Adams) Sargent, both of whom were natives of that state. Ite crossed the plains with ox teams at a very early date in company with his parents and settled in this state, and for the three years immediately following he was engaged in mining. He then purchased a farm of two hundred acres on Deer creek, of which he later sold eighty acres, and upon the one hundred and twenty acre tract which he retained, he established his home and continued to live during the remaining years of his life. He was a veteran of the Rogue River Indian war, having served as a drummer boy for three years, and was with his command during the most dangerous and trying period of that Indian outbreak. He passed away at his home in Josephine coun-

Mr. Sargent was united in marriage on January 25, 1873, to Miss Mary Shoemake, a native of Iowa, who removed with her parents to Oregon in 1872. To Mr. and Mrs. Sargent five children were born, all of whom are still living, namely: Adelbert S., William D., Perry E., Ida M. and Daisy D. Mr. Sargent was affiliated with the republican party, and fraternally was a member of the Independent Order of Odd Fellows. He was a member of the Presbyterian church, as is also his widow, and was a man highly esteemed throughout his portion of the state not only as an industrious and successful farmer but also for the invaluable services which he had rendered as a patriot and soldier in the Indian war. His widow now resides on the old homestead and the farm is being successfully operated by one of the sons of their family.

# KILLS HIS SON-IN-LAW

## Terrible Tragedy Enacted Sunday Morning.

Oliver Sargent, a well known citizen of Williams, was shot and killed on Sunday morning by his father-in-law, W. D. Shoemake. Both parties are old time residents of this county. The sensational nature of the traged and the well known character of both parties has created far more than an ordinary interest in the case.

Shoemake, who is an old man about 75 years of age, lived with his aged wife in a little house adjacent to that of his son-in-law, the buildings being only a few feet apart. Mrs. Shoemake as in poor health, requiring care from the other occupants of the premises. On the morning of the murder, Mrs. Sargent went in to see her mother, and to inform her of an intended absence on a visit to Deer creek. Shoemake at once objected to her going and became quarrelsome to such an extent that Mrs. Sargent left the room and was unwilling to return to take in the breakfast for her parents, as was her usual custom. Mr. Sargent then volunteered to carry in the breakfast, his daughter accompanying him to pour the coffee.

As soon as Sargent entered the room the old man broached the subject of Mrs. Sargent's intended visit, declaring emphatically that should not go; that she must remain to take care of Mrs. Shoemake. Sargent replied that the girls were there to wait on her and that his wife was going. Shoemake reiterated that she should not go, while Sargent again said that she would go and was going. He then turned to place on the tabie the breakfast dishes that he had brought in and as he did so, Shoemake shot him in the back, just under the right shoulder blade, the bullet passing through his body and coming out on the right side of the chest.

Attracted by the shot, Mrs. Sargent and her son, B. S. Sargent, rushed to the scene. Mrs. Sargent arrived first and the son says that when he came in the old man was trying to shoot her and the daughter, but that owing to the weakness of his finger or some other cause, he was unable to discharge the weapon after the first shot.

The boy, according to his statement on the witness stand, seized the gun with one hand and knocked Shoemake down with the other, taking away his gun. The weapon was a revolver, about 38 calibre and was a new one. The Sargent family was not aware that Shoemake had a revolver.

Sargent lived about an hour and a half after the shooting. Shoemake made no attempt to escape, stayed quietly at home and was arrested with out effort Sunday evening by Sheriff Lewis. The coroner, Dr. Flanagan, held an inquest over the body of Sargent, the jury returning a verdict of permeditated murder.

The preliminary examination of Shoemake was held before Justice Furman on Wednesday afternoon and he is held without bail to await the action of the circuit court. The old man evinced no interest whatever in the proceedings, sleepily nodding in his chair with half closed eyes. He claims entire ignorance of the occurrence, saying that "they" tell him that he kitled Oliver Sargent but that he don't remember anything about it. A plea of insanity will probably be entered as his defense.

# WORTHY PIONEER DEAD

### Mrs. I. M. Wagner of Sunnyside Passes Beyond

On Thursday evening, October 23, 1902, at 9:10 p. m., Mrs. C. S. Wagner dled at her home seven miles south of Salem. She was one of the pioneers of 1852, and was as well nown in this cly as any business man, as for many years she made almost daily trips to the city with farm and garden produce, and it was on one of these trips that she was unfortunately thrown from her carriage and severely injured, October 22, 1901. December 19th she suffered a stroke of paralysis, and from all these injuries she was a great sufferer, and finally succumbed. In all her trouble she was animated by a high Christian courage, and bore with great patience what many others could not have borne at all. She was a woman of great spirit, and her only regret seemed to be that one who always done so much for others should finally become a burden and a care to those whom she loved, and for whom her labors were so generously expended.

Deceased was Miss C. S. Adams before her marriage, and was born in Indiana, February 2, 1828. With her parents she removed to Iowa In 1827, where she met and was married to her husband, who is still living, I. M. Wagner, on June 6, 1847. They came to the Pacific coast in 1852, and resided in California until 1860, and then removed to Jackson county, where they resided until 1867, when they removed to Marion county, where they have since resided on the farm at Sunnyaide, south of this city. Deceased was a member of the Methodist church all her life, and filled many honorable positions in that organization. She was a modest, hard-working housewife and mother to her family in every sense. She was the soul of industry, and her heart went out in sympathy to the poor and unfortunate, and no one knows what acts of charity she rendered in many ways to descrying per-

# MRS. WAGNER HAS DIED

As the Result of a Runaway Accident One Year Ago

WAS AN EARLY PIONEER OF THE PACIFIC COAST—A LIFELONG, DEVOTED CHRISTIAN AND ACTIVE MEMBER OF THE METHODIST CHURCH—THE FUNERAL.

Mrs. Wagner has been a lifelong Christian and for many years an active member of the Methodist church and has filled many honorable positions in the same. She was possessed of an extraordinary constitution, and took an active part in the affairs of life until, on October 22, 1901, she became involved in a runaway accident and received injuries from which she never fully recovered, but, on December 19, 1901, she suffered a stroke of paralysis and has been an invalid ever since.

Beside her sorrowing husband tenchildren survive her, namely: Mrs. E. A. Neal, Jefferson; P. M. Wagner, Garfield; A. P. Wagner, Hebro, Ore.; Mrs. A. R. Nye, Portland; A. C. Wagner, Portland; Mrs. M. E. Glenn, Spokane, Wash.; I. A. Wagner, Salem; Mrs. C. E. Bruce, Portland; I. M. Wagner, Jr., and Mrs. C. A. Jerman, Salem.

The funeral services will be held at the Wagner home, seven miles south of this city, at 10 o'clock a. m., Sunday, October 26th, and interment will be had in the I. O. O. F. cemetery.

After exactly one year's suffering as a result of a runaway accident, Mrs. C. S. Wagner, wife of I. M. Wagner, died at her home, seven miles south of this city, on Thursday, October 23d, at 9 o'clock p. m., aged 74 years, 8 months and 20 days.

Mrs. Wagner was one of the early ploneers of the Pacific coast. She was born in Indiana, On February 2, 1828, and removed with her parents to Iowa in 1837. On June 6, 1847, she was united in marriage to I. M. Wagner, and crossed the plains to California in 1852, where they remained until 1860, when they came to Oregon and settled in Jackson county. Seven years later they came to the Willamette valley and purchased the farm near this city where the family has resided continuously since.

"I. M. Wagner, an Oregon pioneer of 1854, died at the home of his nephew, Matt Woods, in Turner, April 3, of a complication of diseases. He was nearly 79 years old. He was born in Iowa July 1, 1827, was married to Miss Catherine Adams in 1847, crossed the plains in 1854 and settled in California, then came to Salem, near which place he has resided ever since. His wife died two years ago. he leaves 10 children—Mrs. Ester Neal, Jefferson; Philip Wagner, Garfield, Wash.; Mrs. C. L. Glenn, Spokane, Wash.; Mrs. Monroe Nye, Mrs. Charles Bruce and Alonzo Wagner, Portland; Adolphus and Perry

Wagner, Tillamook; Mat Wagner and Mrs. D. F. Jerman of Salem." [The Oregon Daily Journal, April 5, 1905 p.10]

### "Oregon Pioneer Dead--

One of Oregon's most highly respected and well-known citizens has passed away, and another place in the ranks of the old pioneers is vacant. I. M. Wagner died at the home of his nephew, Mat Woods, in Turner, yesterday, April 3, 1905, at 10:30 o'clock a. m. of a complication of disease. Had deceased lived until the 1st of July he would have been 79 years old. He was born in Iowa, July 1, 1827, and on June 6, 1847, he was married to Miss Catherine Adams.

They crossed the plains in 1856, and settled in California for a short time, when they moved to Southern Oregon, and finally came to Salem, where they settled on a farm seven miles south of this city, on the Jefferson road, which is an old land mark in this county. It has been his home until the time of his death. His wife preceded him two years ago. Ten children were born to them, five boys and five girls, all of whom are living, and are as follows: Mrs. Esther Neal, Jefferson; Phillip Wagner, Garfield; Mrs. C. L. Glenn, Spokane; Mrs. Monroe Nye, Mrs. Chas. Bruce, Alonzo Wagner, of Portland; Adolphus Wagner and Perry Wagner, of Tillamook county, Mat Wagner and Mrs. D. F. Jerman, of Salem. He also leaves numerous other relatives. Mr. Wagner had just returned a week ago from a trip East, where he went last October, and all during his visit he was ailing, and upon his arrival home he grew rapidly worse, and yesterday morning passed to his final resting place. he was a an of high moral standing, loved and respected by all who knew him. He had a pleasant word for everyone, and his familiar figure will be missed in this city. He was a kind and indulgent father, and his children are sorrow-stricken over his death. The funeral will be held tomorrow at 10 o'clock, at Turner, and the interment will be held at the Odd Fellows' cemetery, in this city, where appropriate services will be held. # Burial Rites Held at Twin Oaks for Mrs. Esther Neal

TURNER, March 15.—Remains of Mrs. Esther Ann Neal, former resident here, were interred at the Twin Oaks cemetery Monday following services at Monmouth. Mrs. Neal, a native of Louisa county, Iowa, shared in early immigrant life, reaching California with her parents in 1852, after spending a winter at Salt Lake City.

She and her brother were the first white children in El Dorado county, California. She came to Oregon in 1861 and marred John Neal eight years later. Most of her married life was spent in the Illihee district south of Salem but after Mr. Neal died in 1904 she lived in Turner for a few years, later going to Monmouth.

Mr. and Mrs. Powers, who live near Chemawa on the Pacific high way, were returning home after having brought Mrs. Charles Mc-Allister, a sister of Mrs. Powers, to Salem from Champoeg, where all had attended the annual anniversary of the establishing of this state as a part of the United States. Mr. Powers was driving about 20 miles an hour, according to his report to police, and had just turned on his bright lights after meeting an automobile when he struck Whitley.

# JESSE MACY, 89, PIONEER HERE, DIES IN NIGHT

Jesse Macy, 89, pioneer resident of Salem and Marion county, died suddenly shortly after midnight Tuesday morning in his home at 193 Miller street. Monday afternoon Macy made his usual trip down town and he seemed to be in perfect health when he retired

Monday evening.

His wife, Elizabeth R. Macy, whom he married in Salem in 1865, five sons, two daughters, and five grandchildren, survive him. Bert W. Macy, Salem attorney, is one of his sons. The other children are Albert M. Macy, and Mrs. Ida May, of Salem; Mrs. Ella M. Morris of Santa Monica, Calif.; Edwin S. Macy of Portland, J. Frank Macy of Pendleton, and Pearl Macy of Portland. A brother, William Macy lives in Carlton, Nebr.

Jesse Macy was born in Wayne county, near Richmond, Indiana. In 1855 his family moved to Henry county, near Mt. Pleasant, Iowa. In 1860 Jesse Macy came across the plains to California with his older brother, Seth. They worked in the mines in Nevada and California and the Jesse became acquainted with some of the men who afterward became famous as bonanza kings.

One of Jesse Macy's proudest boasts was that he voted for Lincoln in the 1860 election. At that time he lacked a few days of being

21 years of age.

In 1863 Macy came to Marlon county and for a number of years he owned and operated the farm at Four Corners, a mile east of the asylum, the house which he built on the farm is still standing at Four Corners.

In April, 1865, Jesse Macy was married to Elizabeth R. Whitley of Salem. Old Squire H. A. Johnson, grandfater of Paul Johnson, Salem merchant, performed the wedding ceremony.

The Macys moved to town 40 years ago. In 1889 and until 1891 the elder Macy operated a livery stable on Commercial street where the Archard implement store now stands.

Jesse Macy was the only one of his family who came to Oregon but two of his mother's brothers, John and Edward Simmons, took up land claims on Howell prairie east of Salem in 1845.

Plans for the funeral have not been made. Rigdon and son will have charge.

Mrs. Macy had lived in Salem slightly more than 43 years. Jess Macy died March 18, 1929.

Seven children survive, Mrs. M. Morris of Los Angeles, Edwin S. Macy of Portland, J. Frank Macy of Pendleton, Albert M. Macy of Salem, Mrs. Ida M. May of Salem. Other survivors include brothers, William C. Whitley of Hamilton, Wash.; Chas. H. Whitley of Pateros, Wash.; sisters, Nancy J. Smith of Springdale, Wash., Mrs. Henrietta Nuttall of Coupeville, Wash.; five grand children and one great grandchild.

Mr. and Mrs. May celebrated their 60th wedding anniversary on April 5, 1925. All their children were present at that time.

Funeral services will be held Friday afternoon at 1:30 oclock from the chapel of Rigdon's mortuary with interment in Lee Mission cemetery.

"JAMES H. SHORTRIDGE, who is living retired in Cottage Grove, has resided near that city since 1851 until his retirement in 1906, owning a three hundred and twenty acre farm which he filed upon as a donation claim in the year of his arrival in Oregon. He is now residing in a comfortable home in Cottage Grove. He was born in Tippecanoe county, Indiana, a son of Samuel Boone Shortridge, whose grand-uncle was Daniel Boone, the noted Indian scout. The parents were both natives of Bourbon county. Kentucky, and they were also married in that state, where they resided for a time, later removing to Indiana. Still later Samuel Shortridge removed to Iowa, settling in Muscatine county, where he bought land and occupied it for some time. It was in that county that his wife passed away shortly after which Mr. Shortridge removed to Mercer county, Illinois, where he made his home until 1852. He then crossed the plains to Oregon, settling about six miles south of Cottage Grove, where he took up a donation claim of one hundred and sixty acres upon which he lived for several years, and then, disposing of that land,

removed to Salt Lake City, where he resided for a few years. On leaving that state he returned to Lane county, Oregon, where he lived until his death, which occurred in July 1876. In his family were seven children, four of whom died in infancy, the others being: James H., of this review; Caroline D., the widow of Hiram Stewart, residing in Eugene; and William Wallis, making his home near London, Oregon.

James H. Shortridge received a common school education in Illinois and one year in advance of his parents crossed the plains to Oregon in 1851 and settled six miles south of Cottage Grove, on a donation claim which his father's farm later joined, residing upon that farm until in 1900, when he disposed of it and retired. During the long period of his occupancy of his donation claim he labored untiringly to get it under a thorough state of cultivation, building suitable improvements, and at the time he disposed of it it was one of the finest farming properties of the community. With his family he now resides in a fine home in Cottage Grove, where he is taking a well-deserved rest and spending his declining years surrounded by his family and friends. Mr. Shortridge was married March 13, 1853, to Amelia S. Adams, who was born in Vermilion county, Indiana, in 1835, a daughter of John F. and Rebecca (Hinkle) Adams. Her father and mother were both natives of Kentucky, their wedding, however, being celebrated in Indiana, where they lived for twenty years. After leaving that state they settled in Louisa county, lowa and resided there for fifteen years, then crossed the plains by ox teams to Oregon in 1852. The eldest son died of cholera on the trip but none of the other members of the family were afflicted with it. Their first settlement in Oregon was made in Salem Hills, eight miles south of Salem, where the father took up a donation claim of three hundred and twenty acres upon which he resided until within a short time of his death, which occurred in October 1870. The mother passed away in July 1876. To them were born ten children, of whom Mrs. Shortridge, who was the seventh in order of birth, and S. Rebecca Rogers, of Turner, Oregon, are the only surviving members. Unto Mr. and Mrs. Shortridge were born seven children, as follows: Emily R., who was born in 1854 and passed away in 1858; Franklin Boone, who was born in 1850 and is a miner at Estacada, Oregon: Mary Rosetta, born in 1857, who married Dr. J. W. Harris, of Eugene; William Johnson. who was born in 1858 and died in infancy; Alice A., who was born in September, 1862, and is the wife of J. J. Weeden, of Lane county, Oregon; Lillie Jane, born in 1865, who passed away in infancy and Sarah O. C, who married Sam Lacy, of Portland, her birth occurring in 1866.

Mr. Shortridge in his political allegiance is a republican. He has taken considerable interest in politics, has served as deputy sheriff of his county and also for many years filled the office of supervisor. In his fraternal relations he belongs to the Cottage Grove Grange while his religious faith is that of the Christian church of which his family are also members. He is among the earlier settlers of Cottage Grove and has always been a leading and greatly respected citizen of the community. He is a man of sterling integrity, strong personality and possesses a strength of character which makes him greatly esteemed by all who know him. In his official positions he distinguished himself by the efficient service which he rendered to the community and both as a public servant and a private citizen he has always been popular.
