In the year now under consideration there are two deaths to be recorded. John Stowell died at his residence in Eugene City, March 17, 1882. He was a native of East Tennessee, where he was born July 7, 1797, and afterwards lived in Indiana, Missouri and California and finally came to Oregon and settled in Lane county at an early day. He was married in 1821 to Margaret Armstrong, who survived him, and lacked but one day of reaching the sixty-first anniversary of their marriage. Mr. Stowell was an industrious, honest, frugal and kind man, and in every way a good and useful citizen, who was held in the highest esteem by all who knew him. John A. Stowell, an Oregon pioneer and a real estate dealer in this city for many years, died yesterday morning at his home, 909 Albina avenue. Mr. Stowell was born in Carroll County, Indiana, in 1836. He came to California in 1856 and to Oregon in 1858, first making his home in Eugene. Later he moved to The Dalles, where he lived until 1682, when he moved to Portland. He married Miss Louise Simpson, daughter of the late Ben Simpson, a prominent pioneer of this state.

Mr. Stowell is survived by one son, a brother, George Stowell, of Juneau, Alaska; two sisters, Miss Leathe Stowell and Mrs. D. B. Gray, of this city. Mrs. Robert Eakin, of Salem, is his niece. For a number of years Mr. Stowell had engaged in the real estate business in Portland. Funeral services will be held today at 2 P. M. from Hol-, man's chapel, and interment will be in Lone Fir Cemetery.



# MRS. J. M. STOWELL DIES

Oregon Pioneer of 1859 Succumbs

at Son's Home in Portland.

Mrs. Janette McCalley Stowell, who died at the residence of her son. Percy E. Stowell, 834 Corbett street, was an Oregon pioncer of 1859. She was the daughter of Andrew and Christine Miller McCalley, and was born in Edinburgh, Scotland, January 29, 1847, and came to America with her parents in 1850, first settling in Prince Edwards Island, a province of Canada.

The family removed to Oregon in 1859, settling at Salem, where the father became the head miller in what in the early '60s was generally recognized as the most important flour mill in the Pacific Northwest.

Mrs. Stowell was married to George Stowell, a clerk in the United States Surveyor General's office, then located at Eugene, in 1870. She is survived by her husband and three children: Percy E. Stowell, Portland; Mrs. Constance J. Andraeson, Manila; George Stowell, Second Lieutenant Unitea States Marines. Haiti.

## WAS A PIONEER OF 1858

Late Alfred W. Stowell, One of Early

#### Day Merchants.

Alfred W. Stowell, who died January 17. in this city, was one of the ploneers of the Oregon country and the Pacific Coast. He was born in Carroll County Indiana, February 26, 1841. His parents, John and Margaret Stowell, moved with their family to California in 1856 and settled on a ranch near Petaluma. In 1858 the family moved to Eugene, Or., where the father died in 1853. Mr. Stowell for years was in the land office at Eugene as chief clerk under William Odell.

In 1867 Mr. Stowell married Elizabeth Blandina Thurston, daughter of Samuel Thurston, Oregon's first Representative, in Congress, He survived his wife by three years.

It was 24 years ago that Mr. Stowell and A H. Morgan, another well-known ploneer of Portland, went into the grocery business in this city at 247 and 249 Front street, between Main and Madison, under the firm name of Morgan & Stowell. This spot is still occupied by a grocery and feed store. Some years later Mr. Stowell went into the brokerage business in this city, and continued in this until he became too feeble longer to attend to his business affairs.

He was a prominent member of the First Presbyterian Church, being for many years an elder under the pastorate of A. L. Lindsley and Rev. A. J. Brown. Mr. Stowell had a small farm on the Columbia River, about seven miles above. Vancouver.

The funeral was held Saturday from the First Presbyterian Church, Rev. David H. Hare, assistant pastor, conducting the service. Music was rendered by the choir. The pallbearers were William M. Ladd, J. Thoburn Ross, S. R. Johnson, Royal K. Warren, Frank Cooper and Fletcher Linn. Mr. Stowell leaves two sons, Walter. Thurston and Curtis, and two daughters, Elizabeth Blandina and Margaret Gertrude.


