"On State Street, about a half mile west of the intersection of State and 119<sup>th</sup> Street, on the brow of a rather steep cultivated field, is a tall oak tree, a lone sentinel in that field. Beneath the tree, it has been said, is an early grave of a male member of the Short family,

as of now unidentified. This area can readily be seen from Mt. Hope Cemetery, north of State Street on 119<sup>th</sup>.

This property was owned by Rev. John Wesley Short by 1870, being part of the Theophilus Powell Donation Land Claim. Rev. Short had a Donation Land Claim in Linn County, as did his father-in-law, Christian Clymer." [Marion County Cemetery Records by Daraleen Wade, Vol 1 p. 145]

#### **REV. JOHN WESLEY SHORT-1853**

John Wesley Short was born in Sussex county, Delaware, on August 23, 1816. A fairly good education was acquired by him while living in Philadelphia and while there he also learned the carpenter trade.

When he reached the age of 19 years he started out on his own merits, going as far west as Burlington, Iowa, then the western metropolis, where he plied his trade.

At the age of 22 years he married Mary Ann Clymer. This was in 1838. They lived for a time on a tract of land which Mr. Short had purchased, or until he became imbued with the desire to go to the western coast.

Early in March of 1853 we find these good folk launching out on the Oregon trail, equipped with two ox teams of five yoke each, one horse and seven cows. Two wagons held their belongings. At this time, besides Mr. Short and his wife, were their six children.

When first they arrived in the Willamette Valley, they settled in Linn county, eight miles southeast of Albany, but in 1860 returned to Marion county, where they continued to reside in the McAlpin district of the Waldo hills.

At the age of 17 years Mr. Short united with the Methodist church. After he moved to Burlington, Iowa, he joined the Baptist denomination and began to preach.

He was fully ordained to preach at Sublimity, Marion county, after his arrival in Oregon, and continued in this work as long as his health allowed him.

He faithfully preached at country churches and schoolhouses throughout Marion county, and especially were his services given at the McAlpin church, in his neighborhood. The writer will remember this Baptist minister, as she often sat under his preaching. He was of medium build with a wealth of dark whiskers, that later on whitened with the years. Naught but good could be said of this grand old man.

He became a successful farmer along with his ministerial duties and accumulated a farm of 740 acres during his long life. His wife died in

"Passing of Rev. Short--Pioneer Baptist Minister Died at His Home at Macleay Early Yesterday Morning--Came to Oregon by Ox Team a Half Century Ago--Will be Buried in Warren Cemetery--Rev. J.W. Short died at the home of his grandson, J.F. Short, in the Waldo Hills yesterday morning at 4 o'clock, aged 86 years, 11 months and 13 days. The remains will be buried at the Warren cemetery tomorrow (Sunday) at 11 a.m.

John Wesley Short was born in Sussex county, Delaware, August 23, 1816. He was educated in Philadelphia and afterward learned the carpenter trade in the same city. At the age of nineteen he began life on his own account. From Philadelphia he went to Burlington, Iowa, where he worked at his trade for a short time. In 1838, at the age of 22, he was married to Mary Ann Clymer, and they lived on a tract of land he had previously purchased until 1853. In March of that year he started across the plains with ox teams and arrived in Oregon August 4, 1853. His outfit consisted of two ox teams, five yokes each, one horse, seven cows and two wagons. The family consisted of his wife and six children.

He settled in Linn county, eight miles southeast of Albany, where he remained until 1860. From that place he removed to Marion county and located in the Waldo Hills where he lived to the time of his death.

Mr. Short became a Christian at the age of 17 years and united with the Methodist church. After going to Iowa, he united with the Baptist church and began to preach. He was ordained to the full work of the ministry at Sublimity, Oregon, and remained a faithful worker as long as his health would permit.

Besides his work in the ministry, he was a successful farmer and had accumulated considerable property, most of it being in land of which he owned 740 acres.

His wife passed away in 1895. The surviving members of his family are Wm. Short, Salem; Mrs. Emma Jones, Jefferson; Mrs. Susan Smith, Drain; Mrs. Jane Hinshaw, Goldendale, Wash.; Supt. G.W. Jones of the State School for the Blind, and C.H. Jones, editor of the Oregon Teacher's Monthly, both of this city, are grandsons of the deceased." Daily Oregon Statesman, June 7, 192 p. 6 c2-3

"Died--At the family home in the Waldo Hills, eight miles east of Salem, Wednesday, December 25, 1895, Mrs. J.W. Short, aged 73 years, 11 months and 8 days.

She was the wife of Rev. J.W. Short and came to Oregon in 1852, locating first near Oak creek, Linn county, and later in Marion county.

# LINN PIONEER OF '52 DIES

#### Silas William Pastor of Tallman

Baptist Church 42 Years.


ALBANY, Or., Jan. 16.—(Special)— Silas Williams, resident of Linn county continuously since he crossed the plains to Oregon in 1852, died today at his farm eight miles southeast of Albany, aged \$5 years.

For the past 56 years he had resided practically all of the time on the farm where he died. For the past 42 years he had served as pastor of the primitive Raptist church at Tallman, performing his ministerial duties in addition to managing his farm. He organized and established this church in the village of Tallman, near which his farm is situated.

Mr. Williams was bern in Missouri and crossed the plains to Oregon when 18 years old. He located in Linn county. In 1856 he served in the Rogue river Indian war, being a member of company R. 2d regiment, Oregon mounted volunteers.

He is survived by three children: Mrs. Addie Short, who resided with him at his farm home: Mrs. Clara Ross of Albany and Edward D. Williams of Portland.

"Death of Emma Jones--Mrs. Emma Jones died at her home in this city Thursday, after a long illness, aged 62 years. She was one of our most respected pioneer ladies, and her death is regretted by all. Deceased was born near Burlington, Iowa, and came to Oregon in 1853 with her grandfather (sic), Rev. J.W. Short, settling in Linn county. She was married to J.W. Jones in 1863, since which time

she has resided in Jefferson and vicinity. She is survived by eight children, G.W. and Kathryn, of Illinois, Charles H. of Salem, Lewis, of Astoria, J.L. Dr. W.F., Mrs. Lulu Wied and Miss Mae Jones, of Jefferson. The funeral services will be held at 2 p.m. today at the M.E. church. The discourse will be delivered by Rev. Douglas, pastor of the Albany Baptist church. Interment will be in the city cemetery, where the remains will be laid beside those of the husband who preceded her to the other shore in 1896. She has lived a long and useful life, and has well-earned the reward which she has been called to enjoy." [Jefferson Review, February 26, 1909 p2c4]

"At Jefferson, Wednesday, July 8, 1896, John W. Jones, aged about 54 years.

Deceased was the father of County School Superintendent, G.W. Jones and C. H. Jones, principal of the East Salem School, and a brother of Mrs. H.A. Johnson Jr., and Mrs. George W. Johnson. He was an old resident of Marion county, having lived here about forty years. He at one time resided near Sublimity. He was a native of Indiana. A wife and seven children survive him.

"Died--At her home near Macleay, on Jan. 29<sup>th</sup>, of typhoid pneumonia, Mrs. Ellen Jones, wife of Thomas Jones, and daughter of Rev. J.W. Short, aged 34 years, 1 month and 1 day.

Since the commencement of her blooming girlhood, deceased has lived in the community where she died, and was extensively known, and universally respected. In her late illness she had the unwearied attention of her husband, relatives, friends, and three skillful physicians, and for the fortnight she hovered close down by the brink of the Sullen River, waiting for the great decision that was to restore her to her husband and children, or waft her weary spirit to the mystic precinct beyond the invisible vail. Her character in all its phases, as developed by the varied experiences of life's accumulating trials was worthy of universal emulation. For more than eight years I have lived a near neighbor to her and her husband, and I am sure this estimate of her character will be heartily concurred in by all who knew her. She certainly had not an enemy in the world, and if a good character in this life insures happiness in the one to come, the change to her has certainly been one of permanent gain. T.T. Geer." "Mary Catherine Short was born in Linn County, Oregon, Ju1y 30th, 1858. Her parents, Elder John Wesley Short and Mary Ann Short crossed the plains from Iowa in 1853 and settled on the Albany Prairie. In 1860 they moved to Waldo Hills, 11 miles east of Salem. In October 1 1878, she came with her parents to Klickitat county, Washington, returning in July, 1875 to Waldo Hills.

She was married September 24, 1879 to Elder Jacob Edwin Adams and returned with her husband to Klickitat county, Washington where they lived six years in the Pine Forest neighborhood, north of Goldendale. In 1885 they moved to her old pioneer home on Spring Creek where she lived until her death, January 23rd, 1931. Her husband was pastor of the Spring Creek and Cedar Valley Baptist churches for twenty-three years prior to his death twelve years ago. She was converted in a Pine Forest revival meeting about forty-seven years ago and joined the Baptist church a few years later.

Her youngest son passed away in November, 1909. The surviving children are Claude, of Klickitat, Washington, Roy, of Colton, Oregon, and Chris, of Goldendale, Washington. Two sisters, Mrs. T.T. Hinshaw, of White Salmon, Washington and Mrs. Susan Smith, of Sutherlin, Oregon survive her.

The funeral services were held in the Spring Creek school house Sunday afternoon at 2:00 o'clock. Rev. W.H. Muston, of the Baptist church officiating, with interment following in the Spring Creek cemetery." [The Goldendale Sentinel, Goldendale, Washington, January 29, 1931, p. 6]
