W. H. ALEXANDER, CONTRACTOR, DIES

William Hite Alexander, weh known contractor in Eugene, died Tuesday morning, having been in poor health for the past two years. Mr. Alexander served as city building inspector for 15 years, and retired about 10 years ago from active duty. He was a member of the Eugene Elks club.

Mr. Alexander was born July 30, 1857 at Shedd, Ore., and at the death of his father, moved to Corvallis, where he resided until 12 years old. He then went to Springfield, and had lived in this section since.

In September, 1900, he was married to Belle Chapman in Eugene, and had since made his home at 142 Thirteenth avenue west.

Surviving are his wife, Mrs. Belle Alexander, one half-sister, Mrs. Bert Vincent of Blue River, Ore.; one half-brother, Charles Davis of Coquille and a nephew, Claude Davis of Morton, Wash.

Funeral arrangements will be announced from the Poole chapel.

WILLIAM H. ALEXANDER. Except as his work appeals by its substantial, practical, or artistic nature, one builder is hardly distinguished from his brother worker in the same field. To be able to give general satisfaction in a given direction, is to hold in one's hand an assured success, no matter how keen the competition, or how large or small the dimensions of one's ambition. The builder of ability understands the requirements of a discerning public, and, keeping well in advance of his time-honored calling, is rarely wanting in material upon which to exercise his skill. Eugene is not behind in being able to produce master craftsmen, men who

have contributed to its fundamental growth by housing its people and industries, and establishing the harmonious aggregate for which the city is famed. Of this class of men W. H. Alexander is essentially a leader, having for the past eighteen years followed the best tenets of construction, making a specialty of artistic and conveniently arranged homes, but also putting up a number of public buildings, including the Risdon and Conser blocks. Among the residences which attest the skill of Mr. Alexander, and materially add to the architectural appearance of the city, may be mentioned those of F. E. Dunn, S. B. Eakin, T. G. Hendricks, W. T. Caro, Mrs. Sarah H. Patterson and the Schwarzschilds home.

A native son of Oregon, Mr. Alexander was born on his father's donation claim near Shedds, July 30, 1857, and is the second of the three children born to Joseph R. and Elizabeth (Nethall) Alexander, natives of Illinois and Scot-land respectively. Through his marriage in Illinois Joseph R. Alexander became identified with a Scottish family of illustrious lineage, for Elizabeth (Percival) Nethall, the mother of Mrs. Joseph R. Alexander, was the daughter of a Scotch nobleman. Mr. Nethall was born and reared in England, and became a very early settler in Illinois. After his death, his wife married Joseph Hite, who came to Oregon in 1853. "lling on a farm in Linn county. Previous to her marriage Mrs. Alexander went by the name of her step-father, and was known as Miss Hite. Mr. and Mrs. Alexander crossed the plains in an ox-train in 1853, and took up a donation claim of three hundred and twenty acres where Shedds Station has since been built. This land the husband improved and lived on for several years, but finally sold out and lived in Linn county, engaging in teaming between The Dalles and Grande Ronde valley until his death in 1863. For a second husband Mrs. Alexander married Charles A. Davis, a carpenter and builder who located in Eugene in 1870, and is now living retired in that city. His wife died in 1883, leaving the three children before mentioned, of whom Sarah, the oldest, deceased, was the wife of Mr. Smith, and Nellie, the youngest, is the wife of T. B. Lucky of Eugene.

Until his thirteenth year W. H. Alexander lived on the farm and attended the country schools and in 1870 accompanied his mother to Eugene, where he had the advantage of the schools of that city. From a boy he worked with tools, and found diversion in making easily constructed furniture for the house, and in doing odd jobs around the house for his mother. At the age of twenty he worked at the carpenter's trade under W. T. Campbell, an architect of Eugene, after a year being advanced to the position of

foreman, which he held for two years. In 1885 he began contracting and building in Eugene, and has since made this his home, uninterruptedly carrying on a large and remunerative business. He married, in Eugene, Belle Chapman, who was born in the east, and came to Oregon as a child. Mr. Alexander is popular socially as well as prominent in the business world, and is fraternally identified with the Benevolent Protective Order of Elks, Knights of Pythias, Uniform Rank Knights of Pythias, and the Modern Woodmen of America. In political affiliation he is a Republican, but aside from the formality of casting his vote has never identified himself with party affairs. Mr. Alexander holds high place in the esteem of all who know him, and is regarded as one of the reliable and thoroughly substantial men of Eugene.

Mrs. Luckey was a sister of W. H. Alexander of this city and a half sister of Mrs. Bert Vincent, E. R. Davis and Charles Davis, all of Eugene. Her husband is a brother of Joe Luckey, also of this city.

She had been ill for some time. Mr. and Mrs. Vincent were at the bedside at the time of her death.

Little Girl Dies in Tacoma-Little Agnec Luckey, 12-year-old daughter of Lieut. Lester Luckey, now in France, and Mrs. Luckey, died Friday, November 1, at the home of her grandparents, Mr. and Mrs. Thomas B. Luckey, of Tacoma, long time residents of Eugene. The little girl contracted typhoid fever shortly after the Luckeys arrived in Tacoma, the disease causing her death. The body was brought to Corvallis, arriving here on the 1:20 train Sunday afternoon, and was at once taken to the I. O. O. F. cemetery, where interment was made. The child possessed unusual talent and was an accomplished planist. She was a devout little Christian and a ray of sunshine in the home where she resided. The little girl was a granddaughter of the late Prof. E. B. McElroy and Mrs. Agnes C. McElroy, formerly of Corvallis. Her father is first lieutenant in the hydroplane service with the Canadian forces in France. Mrs. Luckey, who is a niece of Mrs. W. S. McFadden, is residing in Salem and is a prominent musician of that city. She was an only child. Rev. J. Cronenberger, pastor of the Christian church, conducted the short service at the grave Sunday, and a quartette, composed of Mesdames R. F. Korschgen, J. S. Taylor, and Messrs. Korschgen and J. Howard Lance, rendeed appropriate music
