HAULE: OFF. - In consequence of lack of patronage, Mr Stephen Robnett has been compelled to cease making regular triweekly trips with his back to the bay. The comparative meagerness of the travel baywards, this summer, has been the main reason, but the citizens over there may take a share of the blame on themselves. Instead of patronizing the hack (except when they want a favor, grais,) they frequently come out on a freight or farmer's wagon, simply because it is a little cheaper. They seem to forget that it costs Mr R. five or six dollars a day to run his back, whether he has passengers or not. The back alone, say nothing of the teams, cost over \$300. By this hack stopping, the bay will lose many a visitor, and the citizens a good many dollars. We are corry that the old gentleman has been forced to cease making regular tr ps. He has a splendid hack and good teams, and will go over any time that a load offers.



#### OBITUARY.

Lucinda Hall was born in Kentucky in April 1811 (exact date is uncertain as the records were lost and her memory did not serve her correctly for the last few years).

Her maiden name was Lucinda Robinette. She was married to Thomas Hall
in Boon county, Missouri. Ten children
were born unto them of which all but
two have crossed over "the river of
death to try the realities of an unknown
future," unknown only by faith in
the Word of God. The Christian is

his word hence not unknown to him

Mr. and Mrs. Hall crossed the plains. in 1847 coming to Oregon.

They first stopped near Oregon City. Then moved near Brownsville where they took up their old donation claim. From there they went to Benton county and about 30 years ago settled where Saginaw now is, and soon after coming here 25 years ago Thomas Hall died. She has lived a widow ever since and labored hard for her own and her children's support.

Mrs. Hall died March 9, 1899, and was buried at Saginaw. Oregon.

#### OBITUARY

Mrs. Jemima Robinett was born in Clark county, Illinois, on October 20. 1833, and at the age of 11 years moved with her parents to the state of Missouri, where they remained

until 1851, when they crossed the plains by ox team to Oregon, leaving St. Joseph. Mol. April 7, 1851, and arrived August 14, 1851, near Corvallis, where they lived on a donation land claim for three years. This trip was marked with danger owing to the presence of hostile Indians. Guards on duty were maintained through the langer territory. Soon after arriving at Corvallis she was married at Brownsville on November 27, 1851, to James Robinett, and from there in 1857 they moved to Creswell, taking

up a donation land claim and living there ever since. The south half of of that original claim.

James Robinett, the husband, died in 1896. He was also a pioneer, coming to Oregon in 1847 from Missouri, attracted by the gold excitement in California in 1848 and 1849. He came to Oregon from California by sallboat from San Francisco to Astoria, being 28 days on the journey.

Mr. and Mrs. James Robinett kept the stage station on the place now occupied by Adam Schmitt, and were well known throughout the community. Mrs. Robinett was generally children living. known by old and young as Aunt Jemima, and administered to the home of her son, Fred Robinett, on

a member of the Baptist church, uniting when she was 12 years of age. the town of Creswell is carved out and was an ardent and tourstent adherent all her life.

She died at Creswell at the home of her son, Fred Robinett, Sunday, July 13, 1919, at the advanced age of \$5 years 8 months and 23 days, leaving surviving her a brother, R. N. Shields, of Spokane, Wash., and living children as follows: Fred Robinett and John Robinett, of Creswell, and Mrs. Judy Chrisman and D. Z. Robinett, of Silver Lake; three other children are not living. There are also 12 grandchildren and 25 great-grand-

The funeral was held from the wants and needs of neighbors and Tuesday afternoon, July 15, Reverend friends all through her life. She was Mr. Green, pastor of the local Metho-

dist church, officiating, and interment being in the Cottage Grove cemetery. where there is a family lot. This centellity was carved out of a donation land claim owned by her father.
