IN THE COUNTY COURT OF THE STATE OF OREGON FOR POLK COUNTY

In the matter of the estates of Montgomery Syron deceased.

Petition for appointment of administrator

To the Honorable Asa B. Robinson, judge of the above named Court. Your petitioner would respectfully represent and show to the court; that Montgomery Syron, died intestate in Polk County Oregon on the 27th day of April, 1901; That at the time of his death said deceased was a bonafied resident of Polk county Oregon, and that he left an estate in said county and estate of the probable value of \$2000. consisting of real estate only. That the rental value thereof is about \$250.00.

That the next of kin and heirs at law of said deceased are as follows, to-wit Rachel Aikman aged 44 years. John Syron aged 37 years. Alexander Syron aged 34 years. Peter Syron aged 31 years. Thomas Syron aged 29 years. Grover Syron aged 27 years and Irma Daniels, aged 25 years. All residing in Polk County Oregon, and the heirs at law of Bell Brown daughter of said Montgomery Syron deceased namely. Earnest Brown aged 21 years, residence unknown. Sylvia Brown aged 17 years, residing Albany Linn county Oregon. Violet Brown aged 16 years residing in McMinnville Yamhill county Oregon. Ruby Brown aged 12 years, residing in McMinnville Yamhill County Oreogn, and Henry C Brown aged 10 years, who was heretofore adopted by John Thomas, and resides with him at Vestiburg Mich.

That Hank Brown father of said Brown heirs has been appointed, has qualified and is now acting as Guardian of the said Sylvia, Violet and Ruby Brown.

That is is necessary and expedient, that an administrator be appointed to take charge of and settle said estate; and that your petitioner is a resident of Polk County Oregon, and is a fit and proper person to act as such administrator the wife of said deceased having long since died.

Wherefore your petitioner would respectfully ask an order of this court appointing him administrator of said estate, and your petitioner will ever pray.
