#### Last Will and Testament of Thomas Gillham decd

In the name of God Amen I Thomas Gillham of the County of Madison being weak in body but of sound mind and memory do make, ordain and establish this to be my last will and testament, hereby revoking all others and I do hereby appoint Margaret L. Gillham my wife to be the executor of this my last will and testament.

Ist It is my will that all my just debts be paid that sufficient of my personal property be sold for that purpose if it is be found necessary.

2nd After the payment of all my just debts and funeral expenses I do hereby devise and bequeath to my beloved wife the farm and improvements hereon which I now live, known as the south east quarter of section seventeen in township thru south range nine west as will more fully appears by a reference to deed bearing date July the nineteenth 1823 from Isaac Gillham Seignor, to me also the west half of the north east quarter of section No. 20 in Township No. Three, north of range nine west, as will also appear by a reference to the above deed.

3rd I also give and bequeath to my son Newton D. Gillham one other tract of land in this county as will sufficiently appear by a reference to deed executed in favor of him the said Newton dated February the 12th 1837 by me.

4th I give and bequeath to my son Lewallyn B. Gillham two small tract of land in said county

known as the land deed to me by George Churchill said deed bearing date March the twelfth 183 as will fully appear by a reference to said deed with the exception of a small piece sold by me to Wm Davidson the precise amount not known.

5th I give and bequeath to my wife all my other lands not described here, will be easily be identified by reference to the papers in my possession which compose a part of this last bequest. 6th Also I give and bequeath to my wife all my stock in horses, cattle, hogs, sheep, oxen wagons, farming utensils of every description also all my household and kitchen furniture of every description.

7th I also give and bequeath to my beloved wife all my ready money also all my books and papers all the above enumerated articles together with every other species of property not herein enumerated either personal or real to be by here disposed of as she may in her wisdom think best 8th I give and bequeath to my son James Gillham one \_\_\_\_ year old colt, known by the name of the "Honey" also one saddle, bridle and martingales, claimed by him also my rifle, guns and accruements.

In testimony whereof I have hereunto set my hand and affixed my seal this twentieth day of February in the year of our Lord one thousand eight hundred and thirty seven Sig: Thomas Gillham

#### Last Will of Margaret L. Gillham

In the name of God Amen, I Margaret L. Gillham of the county of Madison in the state of Illinois being old and infirm but of sound mind and memory do make and publish this my last

will and testament hereby revoking and making void all former wills by me any time heretofore made.

First it is my will that my funeral expenses and al my just debts be fully paid 2nd it is my will that all my personal property, goods, and chattels of whatsoever kind be appraised and sold as by law in cases of administration in intestate estates and the proceeds thereof be equally divided between Shadrack B. Gillham, Jane M. Marlow, and Margaret Lynn (my youngest son and two daughters) on this express condition that they pay to Newton D. Gillham, my son three dollars to L. B Gillham, my son, three dollars and to James G. Gillham, my son, three dollars and to William N. Marlow my grandson, one hundred dollars.

3rd I give and devise unto my youngest son Shadrack B. Gillham his heirs and assigns forever all and every my messuage, lands, tenements and hereditaments whereof I am seized in fee situate in the county of Madison in state of Illinois for a full description reference to deeds and title papers now in mg possession. This express condition that he S. B. Gillham pay to Jane M. Marlow his heirs or assigns three hundred dollars and to Margret M. Linn her heirs or assigns three hundred dollars.

4th Should there be money on hand at my death after funeral expenses are paid it is my will that it he added to the proceeds of the sale of the above mentioned personal property and divided as above stated.

5th And I do hereby constitute appoint my son Luallin B. Gillham sole executor of this my last will and testament in witness whereof I have unto set my hand and seal this eighth day of January in the year of our Lord one thousand eight hundred and fifty signed sealed and acknowledged before us

# CHARLES W. GAY, 87, DIES

WELL-KNOWN PORTLAND MAN
PASSES SUDDENLY.

Sub-Divider and Philanthropist
Well Known Here; Holdings
in Tabor District.

Charles W. Gay, 87, Portland pioneer, subdivider and philanthropist, died suddenly at Astoria yesterday when on his way from his Ocean park summer home to Portland. He had been suffering from heart disease since his illness from pneumonia six months ago, and that was thought to have caused his death yesterday. Dr. C. H. Manlove, Portland, who had been called to his aid, wired Portland relatives of his death.

Mr. Gay was born in Farmington, Me., in 1840. At the age of 18 he was working in the mines at Marysville, Cal. Six years later he came to Portland and purchased a 40-acre farm in what is now a thickly settled part of the Mount Tabor district. For many years he has been subdividing the property for homemakers. Of the farm he owned but four acres at the time of his death.

He was married in 1864 to Minerva M. Gilham, daughter of a ploneer Portland family. Six children were born, three of whom still live. Mrs. Gay died in 19185. Two years later he married Mattie Walton, Portland, who survives. Other survivors are the daughters, Mrs. Nellie Walton, 1533. East Stark street, Portland, and Mrs. Clara Spears, Los Angeles; a son, Rufus Gay, Oregon City; six grandchildren and four great-grand-children.

Mr. Gay was a member of the Mount Tabor Presbyterian church.



#### Newton L. Gilham.

Newton L. Gilham, pioneer newspaper man and for many years a letter carrier in Portland, died at Good Samaritan

Good Samaritan hospital May 14. He had worked on various newspapers in Portland, was a miner, prospector, journeyman printer and mail carrier.

He was born in East St. Louis in September, 1850. When he was two years old his father brought him across the plains to Portland. In



In 1885 he helped organize the Portland branch of the National Mail Carriers' association and was its first president He was instrumental in obtaining the annual vacation for carriers, and improving working conditions.

He married Miss Lillie Edwina Slavin, daughter of another Portland pioneer. He is survived by two daughters, with whom he spent the last years of his life, Ruth Gilham Frick and Addis Gilham Olsen; and two sons, Fred H. Gilham and James L. Gilham, all of Portland.


# DEATH OF FRANK F. GILHAM

WIDELY-KNOWN CIVIL ENGIN-EER PASSES AWAY.

Was Son of Early Ploncer and a Native of This County—Promineut in Railroad Affairs.

Frank F. Gilham, a widely-known civil engineer and Portland pioneer, died at his home, 721 Hood street, at 4:30 o'clock yesterday afternoon, of Bright's disease. He was a son of the late Captain Newton Gilham, of Mount Tabor, and at the time of his death was chief engineer of the Oregon Water Power division of the Portland Railway, Light & Power Company. He served as City Engineer in 1895-6.

His death came very suddenly and was entirely unexpected. Mr. Gilham had



remained at his post-of duty up to the usual hour Saturday night, and appeared in good health. He was taken ill Sunday, and rapidly grow worse until the end.

Mr. Gilham was born in the old family home at Mount Tabor, April 9, 1860, and was 47 years of age. His father was an Oregon pioneer of distinction. The son took up civil engineering, in which profession he was very successful. His special line was railroad work, and on that account he was sought out from among many and made assistant engineen of the Oregon Water Power & Railway Company, in which capacity he acted until the consolidation of all the local trolley lines, when he was promoted and became chief engineer, which position he held at the time of his death. He was held in high regard by his employers and his associates.

Mr. Gliham superintended the building of the Cazadero line for the Portland Railway, Light & Power Company, and also laid out the well-known resort The Oaks, on the banks of the Willamette.

Prior to entering the employ of the Portland Railway, light & Power Company, he was for 12 years assistant to Chief Enginner Kennedy, of the O. R. & N., in construction work.

He leaves a wife and a daughter, Mrs. C. C. Gibson of Portland, and three brothers and three sisters, as follows: C. F. Gilham, of Huntington, Or.; Milo Gilham, of Battleground, Wash.; Newton Gilham, of Hillsdale, Or.; Mrs. Ella Shane, of Mount Tabor; Mrs. C. A. Gay, of Mount Tabor, and Mrs. W. W. Skinner, of Salem, Or.
