### The Late Mrs. Rinearson.

Mrs. Isabella Rinearson, who died at her residence near this city last Sunday morning, was born at Inverness, Scotland, October 16th, 1829. Her maiden name was McDonald, and she emigrated to Australia when 16 years of age. Afterward she was married in Sidney, Australia to W. C. Greaves, of West York. One child was born there, who is now Mrs. Kate Brasel, residing in Portland. Two years alterward passage was taken on a sailing vessel for California, arriving there in the summer of 1850. During their residence in California, three children were born, W. C. and R. L. Greaves, and Mrs. Clara A. Califf of this city. In the spring of 1858, they took passage on the ship Northener for Portland, Oregon, and in 1860 moved to Oregon City, where she was left a widow, Mr. Greaves losing his life in the Rogae river Indian war. In 1866, Mrs. Greaves was married to Peter Rinearson, one of Clacksmas county's most estimable citizens, who died about six years ago. They leave four children, Mrs. Emma A. Freytag, George O. Rinearson, Edward B, Rinearson, and Jacob S. Rinearson. A large number of friends attended the funeral services of Mrs. Rinearson at the Congregational church last Tuesday morning, and Dr. Cowan delivered a very effective sermon. The remains were interred in the Oregon City cemetery. Mrs. Rinearson was held in high esteem by a wide circle of friends,

No decision has yet been handed down in the matter of the petition of R. L. Greaves for letters of administration on the estate of Elizabeth Rinearson, deceased. The Rinearson beirs claim that Mrs. Rinearson left no property to administer upon; that she only had a life lease on the property of Peter Rinearson, and this property reverted to his heirs upon his death. The four Rinearson heirs, George, Ed, Jacob and Mrs. O. E. A. Freytag, amicably allotted the real property among themselves, each taking 50 acres, without the process of going into court for a partition of the premises.

### Terrible Accident.

A special dispatch to the Standard, dated Celilo, Dec. 16, gives the following account of the premature explosion of giant powder, which caused the death of Cornelius S. Rinearson, eldest son of Mr. P. M. Rinearson, and D. S. Moore, residents of "Information has just been rethis city : ceived here of a terrible accident which occurred at Owvhee Rapids, about 10 A.M. vesterday, through the premature explo-sion of some giant powder, instantly kill-int D. S. Moore and C. S. Rinearson, both of Oregon City. Preparations were just being made by Mr. Moore, who has had charge of the explosives, for thawing out about ten pounds of the powder, which was in a frozen state, by heating with warm water. An interval of only two or three minutes had elapsed when a terrible explosion took place, blowing to atoms the cartridge house, and instantly killing Mr. Moore and Mr. Rinearson, who were standing some six or eight feet outside the house. As the powder was still in a frozen condition, the fuse and caps stored at out three hundred feet away, and as no one had handled the powder but Moore, who was a careful and experienced hand at the business, and as every possible precaution had been used to avoid any accident, the cause of the explosion remains a profound mystery. In fact, no other theory can be given than that the powder must have been manufactured from inferior material and thus more liable to spontaneous combustion.



Mrs. Freytag was taken to St. Vincent's Hospital about three months ago for medical treatment. but her condition became so that It was thought advisable for her to return to her home. Mrs. Freytag had been active in church work, having been a member of the Congregational church of this city. She was also a member of the Sola Circle, Women of Woodcraft and Milwaukie Grange, All through her sufferings Mrs. Freytag had a kind word for her friends.

Mrs. Freytag was born on the do-

nation land chaim of her parents, Mr. and Mrs. P. M. Rinearson, who were prominent early Oregon pioneers and lived at the old home until her marriage to O. E. Freylag, who is mayor of Gladstone. Mrs. Freylag is survived by her husband, one son, Clayton, and one daughter. Miss Orva, and three brothers, George Rinearson Edward Rinearson, and Jacob Rinearson; three stepbrothers, Peter Rinearson, William Greaves. 

elected to the Legislature from his county last June by a large majority. He was born and raised in Clackamas county. Mr. Rinearson is recognized as one of the ablest parliamentarians and most forcible speakers in the House.

**IACOB H. RINEARSON**, the popular host of the Vintin hotel, at Grass Valley, is a native Oregonian, his birthplace being Oregon City and the date of that event, July 23, 1875. Peter Rinearson, his father, was a native of Ohio where also his parents were born. Their parents came from England. In 1845, Peter Rinearson came with ox teams to Oregon City and took a donation claim just north of the Clackamas river and resided for four years and there died in 1885. He was a very influential man and was not only a leader among the pioneers but a very prominent citizen until his death. He did more perhaps than any one man to get the state fairs started and to make them popular institutions. The first one was held on his farm. He spent much time and labor in raising well bred stock and his animals took the prizes on many occasions. He was a generous, public spirited man and made many friends and did a vast amount of good in opening up and building up Oregon. He married Isabella Mc-Donald, a native of Scotland, who came to Oregon with her aunt. Her parents died in Scotland

and she came first to California, in the United States, that being in 1849 and dwelt with her aunt in Stockton for some time. Then she came to Portland, where she met Mr. Rinearson and the wedding occurred either in that city or Oregon City. This worthy lady died in 1890, at Oregon City. Our subject was reared and educated in Oregon City and later studied in the State University, entering that institution in 1891. After that, we find him in British Columbia weighing ore for the LeRoi mine one year. Then he returned to Oregon City and in 1897, came to Grass Valley, looking after the stock which belonged to his father's estate. The next year, he purchased the hotel which he now owns, from George Vintin, who erected the same. Since that time, Mr. Rinearson has given his undivided attention to conducting the hotel which he has made very popular with the traveling public.

On February 14, 1900, at Grass Valley, occurred the marriage of Mr. Rinearson and Lottie A. Vintin, who was born in Butte county, California, in 1875. Mrs. Rinearson is the daughter of George C. and Martha (Evans) Vintin, who are mentioned elsewhere in this work. Mr. Rinearson has two brothers, George, an attorney

at Baker City, Oregon and Edward, in Portland. Our subject is a member of the I. O. O. F., the Elks and the Red Men. He and his wife are well known throughout this part of the state and have hosts of friends. Their genialty and hospitality are well known and they have striven, not only to build up their business in a becoming manner, but to assist in the improvement of the country and have certainly done a commendable work.
