Norm. --Two of these certificates (or duplicates) are to be given to each volunteer soldier who may be discharged previously to the discharge of his company, that he may at once receive from the Paymaster the pay, &c., due him, and the captain or other officer commanding the company will certify to the act of the delivery of the duplicate certicates; on these certificates the soldier is " entitled to" his discharge, and should also present his discharge to the Paymaster to have the payment indorsed on it. The discharge is to be given back to the soldier by the Paymaster; the latter only retaining as his voucher the duplicate certificates.

NEWSPAPER, The Oregon Argus, 14 Jun 1856, Vol. II, No. 9, p 2, col. 1: Oregon City, Oregon Territory. Sunday, 14 Jun 1856. DROWNED. On last Saturday Mr. R. F. Whittin slipped from the rocks and fell into the river immediately below the falls on the Linn City side while fishing. He was almost immediately swallowed up in the boiling flood. The body has not yet been recovered. He left a wife and three small childen in almost destitute circumstances. The citizens of this vicinity deserve much credit for their liberal contributions in the way of making provision for the comfort of the family. The widow's god and the orphan's father will bless them in their deeds.

NEWSPAPER, The Oregon Argus, 21 Jun 1856. Vol. II, No. 10, p 2, col. 1: Another Man Drowned. On last Lord's day morning Wm. Mann, a lad of about nineteen years of age, fell into the river just below the Falls, on the Linn City side whilst engaged in fishing, and was of course drowned. On the day previous, the body of Mr. Whitten, who was drowned at the same place a week before, was recovered. Widow Mann, in the untimely death of her son, has been deprived of her principal means of support, and we hope all our good citizens will contribute their mite towards relieving her wants. We have but few poor among us, and the little we are called upon to contribute in this way will make us no poorer in this world or in that which is to come. Pure religion and undefiled, before God, consists in a very large part, in visiting the widow and fatherless in their affliction. He that seeth his brother have need and shutteth up his bowels of compassion how dwelleth the love of God in him? We write not these things to censure our good citizens who are noted for their liberality and many Christian graces, but to stir up their pure minds by way of remembrance. Additional note: The body of Wm. Mann, who was drowned last Sunday, was recovered on Thursday, and buried yesterday.

### February 1892

### February 5.

The boys and I butchered two hogs and a calf for veal. Frank plowed this afternoon. This is Clara's birthday, age 50 years. Edgar sent her an album a a birthday present. I went over to Mr Ford's and set up all night with Mrs. Ford who is very sick.

February 6.

I sold a 240 lb hog and 65 lb veal to the Oswego butcher. I got 7 cents a pound for the pork and 7 cts a pound for the veal. It came to \$21.35. This afternoon peddled apples, cider and vinegar in Oswego. Sold \$8.55 worth. Clara and Frank went over to Mr. Ford's this evening to stay with Mrs. Ford til midnight.

## February 7, Sunday.

Mrs. Ford died this morning at 2.20. Frank set up at Ford's to night. I done the chores around the house.

February 8.

Clara and I went to Mrs. Ford's funeral at one o'clock p.m. Frank drove one team or hack. There was a very large number of neighbors out, there were 56 vehicles in the procession. The pall bearers were Albert Walling, Adam Walling, Mike Long, Riley Hayes, Chris Borland, and myself.

When Mrs. Sarah Ford died a few weeks ago she left an estate consisting of ninety-three acres of land valued at \$5000. Her will admitted to probate named her husband, Frank Ford, as executor, and he has filed with the county court his bond in the sum of \$10,000 as required by law.

declare this to be my Last Will and Testament, to wit:

First; All my just debts and funeral expenses shall be first fully paid.

Second; I give and bequeath to Oscar C. Whitten, Edwin F. Whitten and William J. Whitten each the sum of one dollar (\$1.00)

BIBLE –Family bible in possession of June Whitten, Pendleton OR. Inside is a piece of paper stating the lineage as follows, going backward: Frank Everett Whitten, Oscar Cameron Whitten b. 1852, Richard Whitten b. 1824 Chester Co. PA, Benjaman Whitten b. 1787 christened Feb. 11, Swanborne, Bucks, England; James Whitten Swandourne, Bucks England 1757. Orrin queried June about the bible and wrote me an email on 2 Dec 2010: "I talked to June about this. The Bible is a 1913 edition and was printed in NY by the American Bible Society. The Whitten information though is on a loose sheet in the Bible. Leonard Whitten was not a genealogist and June is certain the information didn't come from him so it got to SLC some other way and time. We don't know whose handwriting it is but June is sure it was not Wilma's, who owned the Bible. The info looks old and it could have come from Oscar since he was around till 1948. Oscar had two brothers who also could have supplied the information."

## OSWEGO HILLS VINYARD & WINERY (web site):

In 1852, Sarah [Davey] and Richard Whitten left Cincinnati, Ohio and came to Oregon with the wagon train. Richard had a Donation Land Claim and they settled in Rosemont. In 1856, Richard drowned above the Oregon City Falls. Later that year, Sarah met and wed Franklin Ford. Mr. Ford had also arrived in Oregon with the wagon train. He was the widowed father of two daughters and Sarah was now a widow with three sons (almost the "Brady Bunch"). Franklin moved onto the Land Claim and started farming. Together, he and Sarah had five more sons and one daughter. Franklin was also a County Commissioner, a veteran of the Rogue River Indian Wars, and a delegate to the Oregon Republican Convention. The land he and Sarah shared their life on and the land Oswego Hills Winery sits on are one in the same.

A Czech-republic immigrant from Prague, Mr. James Spousta purchased this farm in 1915-1920. He worked at a foundry in Portland owned by a Mr. K. B. Hall who was reported to have government contracts to build parts for liberty ships during WWII. Sometime in the early 1940's, Mr. Hall purchased the farm from his employee, Mr. Spousta. K. B. Hall built the farm into a world-class equestrian center that hosted the likes of Roy Rogers' Trigger and Buttercup during their trips to the northwest. Sometime in the mid to late 1950's a lumber baron and his family, the Morley's purchased the farm, then approximately 125 acres in size. Their home was built on the hilltop to the west of the barns. Mrs. Morley was still living there when we purchased the 36 acres, the barns and the original Spousta house from her daughter, Elizabeth Douris.

The property was purchased in December 1996. We lived within a half-mile of the farm for the twenty-five years prior and had admired the property for all of those years. It was an equestrian center with tremendous white barns, lots of horses and activity, and a big part of why we liked living in this area. Located half way between Lake Oswego and West Linn, it is within a mile and a half of either city center, yet in a quiet rural setting. Jerry Marshall, the owner, was an airline pilot with American Airlines for all those years and always had the desire to live once again on a working farm, after having been raised on one in West Pennsylvania. He retired from the airline December of 2000. We have been working diligently since the property was purchased to restore it to a measure of its original majesty.

When we took the place over, all the buildings, fences and pastures were in a state of gross neglect. The former owners and tenants had chosen the ongoing deferred maintenance program rather than annual upkeep and repair. Several of the broken down outbuildings were completely engulfed by blackberries, as were 10 to15 acres of the pastures. There were spots where in the winter we could walk on matted berry vines and be 3 to 5 feet off the ground. With the use of heavy machinery and hard work we planted our present vineyard in the spring of 1997. Although the structures were in a state of total disrepair, the high quality of the original materials and the construction expertise were and are evident as we continue to restore the structures for our purpose as a winery.

During our investigation of the farm's history we visited with Mrs. Rose Mcvay living in Lake Grove, one of the four children of James Spousta, the original owner and foundry worker. She claimed her father grew 9 acres of grapes on the hills south of the barns with good success. This was demonstrated by the wine he made and stored in the basement of the house during the late 1920's through the early 1940's. Our vineyard has been in the ground since 1997 and the site seems exceptional as a vineyard site with southern exposures ranging from SE to SW.

Our plan is to continue the rehab process of the buildings; there are seven original structures and they are all being incorporated into the winery layout. The architecture of the buildings and especially their layout relative to each other has proven to be superb for our use as a modern but nostalgic boutique winery and vineyard. We completed planting the vineyard in 2008 and now have 20 acres of vines in production. This translates into 2000 cases of premium quality Oregon wine each year.

NEWS ARTICLE, Oregon City Courier, 29 Oct 1897: Oscar Whitten and party returned Sunday from a hunting trip to Eagle Creek. They killed seven deer, a panther, lot of birds and trout. The Courier never tasted a finer piece of venison than the one cut from the 200-pound deer, which they killed.

NEWS ARTICLE, Oregon City Courier, 7 July 1899: Oscar Whitten, of Oswego, states that there are a lot of burros running around loose in that neighborhood, some of them half-wild, which furnish amusement for the boys. The youngsters catch and ride the little animals, who wander at will in every direction. Last year a man brought a drove of the burros from California, intending to ship them to Alaska, but he was taken sick and died. Since then the animals have wandered about on the commons, apparently without a master or owner. One of the she-asses now has a young colt. These animals thrive on the plain diet, and live well on scraps of leather, bacon rines, peelings from vegetables, etc.

NEWS ARTICLE, Oregon City Enterprise (Oregon), 26 July 1912: Hattie and Edith Wanker spent last Friday with grandfather, Mr. Oscar Whitten... Miss Nina Wanker and Mr. Winfield Baker attended Chautauqua Saturday night.

NEWS ARTICLE, Oregon City Courier (Oregon), 12 July 1917: Mr. and Mrs. Frank Whitten and children, Ernest Whitten and family, Harley Whitten and Oscar Whitten, of Hazelia, motored to Molalla and celebrated the Fourth there.

NEWS ARTICLE, Oregon City Enterprise (Oregon), 9 October 1914: Mrs. Frank Whitten and Oscar Whitten were visitors at the Bob Wanker home Wednesday afternoon. Little Mildred Wanker is on the sick list.

NEWS ARTICLE, Oregon City Enterprise (Oregon), 30 April 1915: O. C. Whitten, who has been visiting his daughter, Mrs. Robert Wanker, of Medical Springs, Oregon, returned to his home in Hazelia Sunday evening.

NEWS ARTICLE, Willamette Farmer (Salem, Ore.), 28 Oct 1881, p 7: Mrs. Sarah Ford exhibited hop yeast bread, jelly, four jars fruit, two quilts, and two boquets. Mrs. Florence Hayes exhibited butter, eigh\_\_\_\_\_ varieties of jellies, two tidies, and one worsted log cabin quilt. Mrs. Hattie Whitten exhibited hop yeast bread, jelly, four jars fruit, two quilts, and two boquets.

#### Letter, Oswego, Clackamas, Oregon, 16 Apr 1882.

"This is a copy of the original letter written by Aunt Hat, Oscar Whitten's wife when Jim, Burt and Guy Hays' mother died. The postmark says Oswego, Oregon, April 17, 1882. This is the copy of a note that was with the letter.

I thought Jim, Bert or Guy would appreciate having this letter written of their lovely mother at a time when they were too small to remember - by her devoted sister who was with her away out there in Oregon in an early day. Aunt Addie.

#### Oswego April 16, 1882 Dear Ones at Home

Dear Sister Florence is gone to the 'better world' she died at four O'clock, thursday the 14th she had the measles and took one of those bad spells and died in fifteen hours afterwards. it seems as though I was dreaming. I can't stand it my brain reals, but I must be more composed. I am still weak and my head is affected from having the measles. I could not go to the funeral and did not see her after she died. kind friends pursuaded me not to. she was buried yesterday at four o'clock, but her funeral sermon is to be preached two weeks from tomorrow (it was a very rainy day yesterday til just as she was buried the sun shone.) and I was not able to go. Nor were part of the children. Guy is over the measles feeling well so is Addie. Frankie took cold and came near dying, but the good Lord spared him to us. he is much better now. Bertie and Jimmy has not had them yet. I cannot wite no more now. my heart aches and my head swims.

Now I will try and write more Florence was in her right mind til the last but could not speak for three hours before she passed away she told me in a low broken whisper all about how she wanted to be buried and who was to preach the funeral sermon and wanted me to have the children and be a mother to them. she wanted you all to have something of hers. which we will send you as soon as we can. she could not tell all she wanted you to have but spoke of some things. she was perfectly happy and talked of Heaven and Lonnie so much said she dreamed the night before that the angels were hovering around her. Oh how can I bear it. I am going to fulfill her dying requests as long as I live. and I must not give up. We are going to live there in Rileys house as she wanted us too. and I can do better with the children there than on our place. as the house is larger. and things are better in several respects. and then we can leave our place better than Riley

can his but then the places are only quarter of a mile apart. write to Riley he needs consoling although he has been as composed as any man would be under the circumstances. but he has the consolation that he was always good to Florence and done all in his power for her happiness and everything was done for her that could be. while she was sick. and he says everything shall be done just as she wished. she was buried in a new burying ground about a mile from here. that was her wish to have Lonnie taken up and buried beside of her. Oh that you were all here. it seems as though I could bear it better. but the Lord is good I will turn to him for comfort. Hattie Whitten

This letter is copied exactly as it was written, punctuation etc."

#### LISTOPV.

"Note from Orrin Lay, 30 Jan 2010, on the cause of death of Hattie: Hattie was papering her house and standing up on a table to do it. She fell and hit the corner of the table with her side. It caused a growth inside her and she only lived for three months before it took her life. Her oldest daughter Addie was 12 years old at the time so she took over as Mother of the 4 other kids. Zena was 8 and little George Leslie (Pete) was a year old. It was really tough for them and they were very poor. They lived on the old donation land claim on what is now "Whitten Lane" in Oswego. Oscar never remarried but just raised the kids. I remember him well when I was 3 years old. He lived with Bob and Zena and would sit in the corner chair and I would sit on his lap. Do you have a copy of his life story? I have it here if you don't. He was a real Oregon Trail Pioneer."

NEWS ARTICLE, Oregon City Enterprise (Oregon), 14 August 1891: We are sorry to report the death of Mrs. Oscar Whitten. Her remains were buried in the Oswego cemetery. [Also, Misses Ruth and Minnie Copley were in Oswego Friday. They are the granddaughters of Franklin and grand step-daughters of Sarah.]

#### OBITUARY - Near Oswego, Clackamas, Oregon, Aug 1891.

"Died -- Near Oswego, Oregon, 6 Aug 1891, Hattie N. Whitten, wife of Oscar C. Whitten, age 34 years, 5 months, and 28 days (Johnson Co., Nebraska, Van Buren Co., Iowa, and Minnesota papers). Hattie Newel Phillips Whitten was born in Van Bureau Co., Iowa, moved with her parents to Tecumseh, Nebraska, at an early age, and from there to Oregon in spring 1877 where she was married the following September to her now bereaved husband. She left five children to mourn a mother's loss. She united with the Christian Church when but 13 years of age. At the time of her death she was not a member of any church, but her patient fortitude through her three months of suffering was proof that she relied on an arm of strength and safety. Her last hours will never be forgotten by the many relatives and friends who clustered around her bedside at her request to hear her last wishes. First in her thoughts were her dear children and husband, then her far away parents, but not one of her many friends were forgotten. She planned the arrangements for her funeral perfectly; who were to conduct the services, singing, and to act as pall bearers, and where she will be laid to rest, and finished with the request to be covered with pretty flowers, as in life she loved them. She often repeated the words, "I am so happy; I have no fear to die; a group of dear ones is waiting to receive me." By her request the Rev. R. M. Jones conducted the funeral services, and the choir, of which she had been a member, sang, "Nearer, My God To Thee," "Asleep in Jesus," and "Sister, thou Wast Mild and Lovely," the same pieces that was sang at her sister's funeral nine years before. A loving and affectionate wife and mother, and useful member of society has gone to rest. - Mrs. Locey."
