“Thomas Flett was born in Scotland in 1814. He arrived in Oregon in 1851, marrying Louise (Lizette) the same day, June 22. Somewhere east of the Rockies he had taken for a wife Nancy Kootenay who had borne him a daughter Clementia, and whose death is unrecorded. His claim south of Woodburn was disallowed after some years of apparent dispute, as was often the case when boundaries were vague or unrecorded.” [Catholic Church Records of the Pacific Northwest St. Louis, Vol 1 A-4]

“The name Flett also returned to the Colville area. Nineteen year-old Scottish born Thomas Flett joined the HBC in 1833 and three years later was sent to Kootenay Post on the south side of the river, in the middle of the famed Tobacco Plain. Although 400 miles from Colville, it was still south of the later boundary. There Flett traded furs, buffalo skins, deerskins, and `what was valuable' until he was reassigned to Fort Colville in 1840, leaving old Berland in charge. Thomas spent another decade at Colville; then he went to the Willamette Valley in 1851. In taking a place south of present Woodburn he was a bit removed from the center of the French-

Canadian community but close enough to be within St. Louis parish.....” [Children of the Fur Trade by John Jackson p.267-68]

[This Blessed Wilderness - Archibald McDonald's Letter from the Columbia, 1822-4 edited by Jean Murray Cole, UBC Press, Vancouver/Toronto, 2011, page 135]

1838: Archie wrote on November 5, 1838 to James Douglas at Fort Vancouver, complaining that Francis Ermatinger was reassigned to another place and no one was sent to replace him. He had newcomer, Angus McDonald, but he was with the Flatheads on the plains. "Mr. Ferris, indeed from his knowledge of the French & some experience as a trader, would, I thought, have answered much better, but he, I understood, was specially appointed for Fort Vancouver.

[Hypolite] Brouillet goes put in the spring, and I am not very clear that Thomas Flett can be relied upon. There is not a word from either of them this fall yet."

1840: Archie McDonald writes on January 10, 1840 that Thomas Flett was with the Kootenais.

1840: From "This Blessed Wilderness - Archibald McDonald's Letters from the Columbia, 1822-1844" edited by Jean Murray Cole, UBC Press, Vancouver/Toronto, 2001, page 155:

Archie McDonald wrote from Walla Walla to Samuel Black at Kamloops on June 5, 1840: "On safely landing here this morning we were handed a packet from Mr. McLoughlin of 13th ult. containing with other papers the enclosed letter by which you will see all three anticipated him as to the summer arrangement's; further remarks on this head are unnecessary. We thought it advisable to send back William Pion ... As it is likely you will be sending him to OK (Okanogan) soon after his arrival, have the goodness to order Thomas Flett to make up 6 elk skins to take down for Mr. Ogden. If there is no gum at Okanogan, Gingras ought to get a little ready for the Colvile Boats by the time they return, as we find Mr. McL. puts in requisition all I brought down this summer.

..In the afternoon another packet cast up from the Dr. announcing that Mr. Lee & the Wallamette ship came in on 23rd. There is about 24 preachers & other subjects for that mission ... Tomorrow morning, God willing, we make a start. The water is remarkably high & not yet at its height."

page 156: Archie McDonald writes from Walla Walla on July 9, 1840 to Rev. Elkanah Walker at Tshimakain Mission, his wife and family were visting the Walker's from Fort Colville:

"We start tomorrow morning [back to Fort Colville] ;;at same time that three of my people for the harvest work, accompanied by Mr. Demers, proceed by land. One of them is our little [David] Flett whom I send over to assist the wife & children to get home..."

In a letter to Rev. Walker on August 17, 1840 from Fort Colville, Archie McDonald wrote him that the son of Big Head had delivered Walker's letter to him. Also that the son wanted pay for a horse that Big Head had given to McDonald's children. He did not pay him but said he would pay Big Head in person. "I believe Flett sends him 3 feet of tobacco & a little ammunition en attendant." Fur trade tobacco was braided into rope-like strands.

1851: June 19 "I married Thomas Flett & Lizette Heibart... I baptized her at his urgent request... Upon her professing faith in Christ and a desire to live a Christian life although she is ignorant of religious truth... I administered the ordinance, enjoining upon him to read to her the SS & the prayers of the Presb'n church and to teach her & to let her go to meeting and learn in every way. He is from the Orkney Islands & a member of the Scotch Presb'n church....I gave him some primers & other books to read & to instruct his family." [Diary of Rev. G.H. "Olivier Brisbois, from Montreal, first appears in 1847 with the baptism of his daughter Catherine at Walla Walla, Father Joset seems to have been on his way downriver to Fort Vancouver when he halted at Walla Walla on May 18th to baptize five children and one young man. Catherine's mother,, William Wilson. Brisbois' wife, Catherine Cayuse (so given in the St. Louis Register) died some time later. Brisbois placed his three-year-old daughter in the care of the Sisters at St. Paul. He lived for a time between Marion County, Oregon, and Fort Hall in Idaho. In 1852, at St. Louis, he married Jane Flett, a fifteen year old metises who had come as an infant in the Red River Migration. Brisbois was a Third Corporal in the Yakima Indian War from Walla Walla County, for by this time he had settled at Frenchtown with his wife and one child, probably little Jean Thomas. A host of other children were to follow. The Brisebois name is one of those inscribed on the common monument at St. Rose Mission

cemetery." [Catholic Church Records of the Pacific Northwest, Vol 1 and II Vancouver and Stellamaris Mission, p. A-11]
