AN OCTOGENEREAN DEAD .- The Stayon Times says. Wednesday morning, February 3rd, 1892, Mrs Susan Crabtree died at her home five miles south of Stavton, in her 82 year. In the death of Mrs Crabtree this community loses another estimable pioneer lady. Deceased was born in Hopkins county, Kentucky, February 14th, 1816, and married in the same state to Washington Crabtree in 1831. In the year 1836 they emigrated and settled in Cedar county, Missouri, from thence in 1853 to the state of Oregon, where they have since resided. Mrs Crabtree became a member of the church of Christ in the year 1835 and until her death lived a consistent christian life. Her dying words were, "No more water until I shall drink the water of Life over yonder." Deceased leaves a husband and three children, one of whom has always lived with his parents, and the other two, Mrs A J Richardson and J I C Crabtree, reside here.

Should he live until October 2d he will be 94 years of age.

The judge also made an order authorizing Mrs. Crabtree, as administratrix, to sell the balance of the personal property belonging to the estate at private sale.

STAYTON, Ore., April Mrs. S. G. Crabtree passed away at her home on Saturday afternoon at 2 o'clock, after an illness of three weeks. Deceased was 73 years and 4 months of age, and was the mother of 5 children: M. J. of Mehama and J. K. of Hood Rixer; Everett Crabtree, Mrs. Nora Taylor and Mrs. Grace Holford of Stayton, also three step children, W. W. Crabtree of Staymn. T. C. Crabtree and Mrs. Mary ownsend of Salem, all of whom urvive her. She also leaves a brother, A. D. Gardner of Stayton. and two sisters, Mrs. J. R. Gardner of Stayton and a sister in Albany. Funeral services were held from the Christian church of which she has long been a member, Monday afternoon, and the remains laid beside those of her husband, who passed on several years ago. The many beautiful floral tributes gave silent but eloquent testimony of the High esteem in which she was held by the people among whom she has lived for so many years.

DIED-A. J. Richardson, father County Treasurer Richardson, died at the home of his son, in this city, Friday, at the age of about 73 years. He was a pioneer of the Willamette valley, having crossed the plains in the immigration of 1851, and located a few miles from where Scio now stands. In the seventies he became a resident of Marion county, locating at Stayton, where for many years he conducted a hotel and livery business. He leaves three children, Mrs. Wiley of Seattle, W. Y. Richardson of this city, and Warren Richardson of Stayton. His wife survives him: and lives with her son at Stayton. Deceased was a lifelong and consistent member of the Christian church, and his death will be deeply mourned by many old friends and pioneer residents of western Oregon. He leaves three brothers, Dr. J. A. Richardson of Salem ;E. T. Rich-ardson of Spokane, John W. Richard-son of Scio, Waddell Richardson of Moro, Wasco county. The funeral will be neld at 11 a. m. Sunday at Stayton. Funeral services were held at the residence of W. Y. Richardson on Che-meketa and Twelfth streets, Salem, Saturday at 9 a. m.

Thomas McClain Munkers, whose death occurred in this city Thursday, June 15, 1899, was born in Clay county, Missouri, June 22, 1833. He crossed the plains with his parents, five brothers and three sisters, in 1846, and settled on a farm near Salem. In 1848 he went to the mines in California, acompanied by two brothers, Benj. and Marion, the latter dying the following year as they were ready to return home. In 1854 he again went to California, stopping at Yreka two years, and while there he took an active part in the war with the Indians, who had become quite troul 1 some in Northern California and Sout ern Oregon. In 1857 he moved onto a farm three miles west of Scio, where he resided until seven years ago, when he moved to this city where he remained until his death. He was married to Phoebe A. Crabtree on May 5, 1859, and together they lived in happiness until August 26, 1868, when death darkened the threshold of their home and claimed Mrs. Munkers as its victim. Again on January 13, 1870, he was married to Mary Chrisman, who still lives to mourn the death of a kind and loving husband. In 1870 he represented Linn county in the house of representatives. Again, in 1876 he was elected to the senate, and in 1896 was a member of the legislature.-Scio News.
