"CASE, WILLIAM M.--Born in Randolph County, Indiana, in 1820. Set out for Oregon with his family in 1842, but being compelled to delay his progress, arrived here in December, 1844, having crossed the plains with ox-teams in the ordinary manner of that date. He settled with his family on a donation claim of six hundred and forty acres, three miles south of Champoeg, Marion County, where he still resides. He went to the California mines in 1849, remaining one summer. Held the office of county commissioner of Marion County for eight years. Married Sarah A. Potter in 1841. Children Mrs. Fanny Moreland, John N., Mrs. M. E. Felt, Mrs. Alice Borthwick, Mrs. Annie Hoyt, Mrs. Jane E. Croghan, Geo. W., Elenora, and Ida Bell. Mrs. Case was born near Mount Holly, New Jersey, January 17, 1822, but was reared to woman hood in Wayne County, Indiana. She died March 30, 1877." SANE FOURTH RECALLED BY PIONEER OF OREGON

Mrs. Borthwick Remembers When Case's Oxen Loped All the Way From
Farm to Butteville—Grand Joy Ride Precedes Big Celebration.



THERE are residents of Oregon today who remember well one Fourth of July celebration that was sane in every particular. Mrs. A. E. Borthwick, of this city, a daughter of the late Mr. and Mrs. W. M. Case, pioneers of 1844, although only a small child at the time, says she can remember distinctly the happy faces of her family and their neighbors as they sat upon a large hayrack drawn by her father's oxen. The oxen did not move along with that "crossing-of-the-plains jog. They seemed imbued with the happy spirit of the occasion and "loped" all the way from the Case farm to Butteville, a distance of five miles. No other yoke of oxen passed them, although several attempts were made amid great cheering and waving of flags. This was indeed a "joy ride." These oxen were known far and near as "Case's loping oxen."

Mrs. Borthwick remembers the busy days of preparation among the neighbors, the beautifully starched dresses and bright ribbon gashes newly ironed,

of the women and girls and the elegant dishes prepared by her mother and her friends; for the banquet was to be the greatest that Oregon had ever known.

Neighbors Like Big Family.

"The neighbors were like one big family in those days near Butteville," says Mrs. Borthwick. "They stood by each other in all joys and sorrows. On this occasion all laughed and chatted at a great rate. A large platform had been erected in the woods at Butteville, a table was made that reached from end to end of the platform, and this was loaded down with the good things cooked by the women and girls of Marion County. The table decorations were wild flowers and flags, beautifully arranged.

"The babies were there also, wrapped in their mothers' great shawls. They, too, were happy.

Boys and Girls March.

"The Sunday schools from all parts of the country sang, marched and counter-marched. The boys were in white waists and the girls in white dresses

with wreaths of wild flowers woven in their hair.

Proudly they kept step, or tried their best to do so, to the inspiring music of the Aurora band, which at that time consisted of 25 pieces. There were foot races and games and the banquet. How good everything tasted out there in the beautiful woods!

President Hoyt, of Willamette University, delivered the oration. There was dancing in the evening in which old and young took part.

At the recent reunion of the Oregon Pioneers in this city, Mrs. Borthwick mentioned this first Fourth of July celebration. An old lady who overheard the remark said: "Yes, I remember it, too. I was invited to go home with your mother and family. I passed the night with them."

Oregon Apple Known Early.

In 1857 Butteville and Champoeg had several warehouses and stores. At that time Marion County was almost one vast grain field; many apples were shipped from these points to California. Discovery of gold in that state had made available the sale of Oregon products. Shipments were made by steamer, as there were no cars at this early date. Boats could not reach Salem during low water.

"Babylon fell because its land trade was taken away," says Mrs. Borthwick. "Butteville lost its trade upon the completion of the Oregon & California Railroad. Previous to this great wagon loads of wheat and oats were hauled by the Case home into Butteville upon the road leading into the main road that is still called the Salem-Butteville road. This road was made the very best and the people were justly proud of it. It is in good condition at the present time. Mr. F. X. Matthieu lived beside this road at one time, later removing to Butteville. His home was as well known for its hospitality as the Case home. Mr. Case's home had sheltered many of the Whitman refugees after the massacre of Waiilatpu.

SUDDEN DEATH.

**Judge Samuel A. Moreland Expires of Heart Disease
at his Residence Last Night.**

Ex-Police Judge S. A. Moreland died very suddenly at his residence at Twelfth and Clay streets at 11 o'clock last night. For the past five or six weeks he has been troubled somewhat with shortness of breath and slight pains in his chest, but as he suffered no serious inconvenience from it, he attributed it to some slight disorder of the lungs. Last evening he ate a hearty supper, and then went to lodge. About 9 o'clock he returned home and after going to bed commenced reading. All of a sudden he was seized with a paroxysm, and a sharp pain through the breast, followed by a fainting spell. Mrs. Moreland, who was attracted to the room by the noise of the dying man's struggles, administered camphor and other stimulants as soon as they could be procured. Dr. Watkins was summoned with all possible haste, but just as he arrived Judge Moreland gave one gasp for breath, and then all was over. Heart disease is the supposed cause of his death.

As might be supposed, the family were heart-broken at the terrible event, and it was with the greatest difficulty that kind friends could in any way console them.

S. A. Moreland was born in Jackson county, Tennessee, November 1, 1836, and at the time of his decease was 49 years of age. He came to Oregon in 1852, and for a while taught school. He studied law with Smith, Grover & Page, and was admitted to the practice of the profession in 1863. In 1865 he was elected assessor of this city, and in 1872 as justice of the peace. He resigned this position to become associate editor of THE OREGONIAN. This place he filled with credit for eleven years, and until he was appointed police judge during the year 1881. On January 1, 1872, he was united in marriage with Miss Fanny A. Chas. Deceased leaves a daughter aged 8 years.

Many old Oregon pioneers and many of the younger generation will be shocked and grieved this morning to hear of Judge Moreland's death. He was an honest, warm-hearted, kind, just man, slow to make friends because he lacked somewhat in suavity of manner, but ever sincere in his friendships. In every public matter he was always on the side of right and justice. We young men on THE OREGONIAN staff, with whom he was intimately associated for a number of years, learned to love him, and in the daily intercourse which extended over a long period, never an unkind word was spoken nor an unkind thought harbored. This same feeling remains, and our association with Judge Moreland will linger as a sweet memory through years and years.

We who trudged across the plains in the long ago now see those who were the youthful companions of our own youth in the days of that journey falling around us, reminding us of the flight of time and bringing up with frequency strange suggestions of the mysteries of life and death. Samuel A. Moreland has passed away. He came here thirty-four years ago, a boy like ourselves; he went through all labors and privations incident to life in those days, and shirked no duty. Looking back over the lapse of all these years, we can still see him as he came up in that part of Clackamas county, then and since called "Hardacrabble," where we toiled together. Faithful duty there seasoned him for after service. Through something like what a great writer calls "a divine thrusting on," he sought education and came to Portland, where he built the fires and swept the old academy on the hill to pay his school expenses. Applying himself to legal studies, he was admitted to the bar, but after no long time he came to THE OREGONIAN, where he did faithful, excellent and conscientious work for many years. Subsequently he became police judge, from which position, as all remember, he recently retired. In every relation in life Samuel A. Moreland was an honorable and worthy man. All his friends, and especially his early friends, will pay to his memory the tribute he would have paid to theirs. Peace to him forevermore.

by Woman Who Took Prominent
Part in Women's Activities.

The funeral of Mrs. Frances Moreland Harvey, a member of one of Oregon's pioneer families, who died at her home, 1563 Stanton street, Tuesday evening, will be held today at 1:30 P. M. at the residence. Final services will be at Lone Fir cemetery.

Mrs. Harvey was born while her parents, Mr. and Mrs. William Case,

were en route to the state of Oregon from Indiana in 1844. The family on several occasions had narrow escapes from the Indians. While coming down the Columbia river on a flatboat Mrs. Case and the baby girl were swept overboard, but were rescued, little the worse for the incident.

The Case family settled near Euterville in Marion county and it was there that Mrs. Harvey spent her girlhood. She was a graduate of the Willamette university at Salem in the class of 1866 and was also one of the first white women to make the ascent of Mount Hood, this occurring in the year 1867.

Mrs. Harvey was first married to Samuel C. Moreland, a newspaper writer and a brother of the late Judge J. C. Moreland. Her second husband was E. G. Harvey of Portland.

Mrs. Harvey traveled extensively and often contributed to the press on matters of interest. She was well known as a clubwoman and was especially interested in music and musicians. She was an enthusiast for Oregon plants and scenery and her home in Portland was beautified with plants and trees of this state.

She is survived by two daughters, Mrs. Horace W. Thielsen of Butterville and Mrs. Waller E. Tyler of Los Angeles; two brothers, John Case of Omaha, Neb., and George W. Case of Hubbard, and five sisters, Mrs. Alice C. Borthwick of Portland, Mrs. Jennie Garon of Victoria, B. C.; Mrs. Anna Maxwell of Portland, Mrs. Elia Cranston of Buenas Aires, and Mrs. Belle Gibbons of Los Angeles.

INVALID SIXTEEN YEARS

John Nathaniel Case, 79, a resident of Omaha and Sarpy county for the past fifty-two years, died at his home, Fort Crook boulevard, Monday morning.

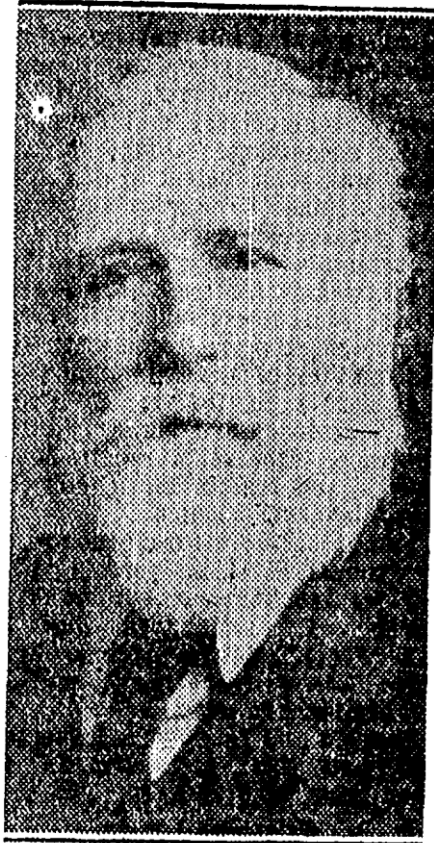
Mr. Case was born February 12, 1845 near Portland, Ore. Surviving relatives say he was the first white child born in the state of Oregon. He was a scout in the civil war in Oregon and Washington and served under General Sherman in the campaign against Indians in Montana in 1868-69.

Coming to Omaha in 1870 he carried pony mail north to Fort Calhoun for the Wells Fargo pony express. In 1871 he married Miss Mary Agnes McGee of Council Bluffs. He worked for seventeen years for a smelting and refining company but when his health broke went to farming. He had been an invalid for sixteen years and had been cared for by his wife, Mary, who survives him. Other survivors are four sons, Robert W., Arthur N., William, of Omaha and Harry M. Case of Craig, Neb., three daughters, Mrs. J. L. Rady, Mrs. R. L. Moore of Omaha and Mrs. Ruth Whitman of Long Beach, Cal., twenty-eight grandchildren and one great grandchild.

Funeral services will be held at 2 o'clock Wednesday at the Brewer chapel with the Rev. C. C. Wilson officiating. Burial will be in Grace-land Park.

CARRIED INDIAN'S
BULLET 56 YEARS



John N. Case.

John N. Case, 79, early Indian fighter and pony express rider, who died Monday, carried with him to his death an Indian's bullet which lodged behind his ear during the Mormon massacre fifty-six years ago. Mr. Case had been deaf in the left ear because of the injury. Doctors had always advised him against having the bullet removed, for fear it might prove fatal.

At the time of the Missouri river flood in 1882, Mr. Case was working for the Grant Smelting & Refining Co., now the American Smelting & Refining Co. plant on lower Douglas street. When the high water reached its crest, he painted a mark on the company office. The mark still remains. During the flood, Mr. Case saved 85-thousand dollars worth of gold bullion from being washed away.

IRA W. FELT DEAD.

Record of a Busy Life Ended in This City.

Ira Wenthal Felt, late of Los Angeles, who died in this city last Tuesday, and whose funeral will take place from Trinity church, at 2 o'clock today, was born at Earlville, Onondaga county, New York, and was a direct descendant of families connected with the earliest period of the history of America. His mother was a descendant of one of the celebrated Knickerbocker families, the Stuyvesants, of New York, while his father was a descendant of the Endicott who came over in the Mayflower.

Mr. Felt passed his youth in the East, where he graduated from a college, and came to California, by way of Panama, early in the '50s. His experiences on that trip were full of danger, and his life was placed in jeopardy on several occasions. While on the journey he was robbed by filibusters, and almost lost his life at Nicaragua. He was twice laid low with yellow fever, but, thanks to a good constitution, recovered his health, and finally arrived in California.

He was one of the oldest commercial travelers on the coast, and was for years connected with one of San Francisco's important music houses. He was also a veteran member of the Independent Order of Odd Fellows, being an active member for 30 years, of Temple lodge, No. 17, of San Francisco.

One of his cousins, Andrew Felt, was republican governor of Kansas, and is now editor of the Kansas City Times. Headley, the historian, is also a cousin of the deceased.

For the last seven years, I. W. Felt made his home in Los Angeles, where his only living sister and brother, Mrs. L. F. Briggs and Mr. Paul Felt, now reside.

Mr. Felt was married October 24, 1873, to Miss Mary E. Case, daughter of William M. Case, of Marion county, a pioneer of Oregon, having crossed the plains in 1844. Mrs. Felt, the widow, and two daughters, Lubel and Gladys, are left to mourn the loss of a devoted husband and father. Mrs. Felt is a sister of Mrs. L. H. Maxwell, Mrs. A. E. Borthwick, Miss Ella Case and Mrs. E. G. Harvey, and an aunt of Mrs. Horace Thielsen, all of Portland; also sister of Mrs. C. C. Gibbons, of Los Angeles.

G. A. R. MAN IS BURIED

FUNERAL OF A. E. BORTHWICK ATTENDED BY MANY COMRADES.

Late Portland Resident Was Oregon Pioneer, and Assisted in Early Railroad Construction Work.

The funeral of A. E. Borthwick, widely known pioneer and Grand Army man of Oregon, who died October 31, was held Saturday, November 3, from Miller & Tracey's undertaking parlors. A number of Grand Army men of Portland and other communities of Oregon were in attendance at the obsequies.

Dr. C. E. Cline was in charge of the service and preached the funeral oration. Supreme Justice McCamant came from Salem especially to attend and deliver the eulogy. Rev. N. E. Wade, chaplain of George Wright Post, Grand Army of the Republic, and Rev. W. T. Kerr spoke. Mr. and Mrs. J. S. Hamilton sang. Burial was at the Grand Army Cemetery.

Besides having enjoyed a wide circle of friends in Army ranks Mr. Borthwick was equally well known as a railroad construction worker and in business. In public affairs in the late '80s he was also active and was Deputy County Clerk for several terms, later being elected County Clerk.

Mr. Borthwick enlisted in the Union Army at the outbreak of the rebellion and served in two branches, the cavalry and the artillery. He was only 16 when he enlisted the first time. Shortly after the war he started westward, and for several years assisted in building the Union Pacific and Central Pacific railways. Later he engaged in mining activities in Idaho, Montana and Nevada and reached Portland in the Winter of 1869. He taught school for a time and was later engaged also with the Oregon & California and the Northern Pacific railroads.

During later years Mr. Borthwick gave his attention to real estate and allied interests.
