OREGON PIONEER IS DEAD

William Churchill, Who Crossed Plains in Ox-Cart, Dies.

COTTAGE GROVE, Or., May 18.— (Special.)—The funeral of William Churchili, head of one of the first dozen families to settle in Oregon, was held here Thursday morning from the Christian Church, V. E. Hoven officiating. Death occurred May 12 from paralysis. Mr. Churchili had passed his \$7th birthday and was in good health and his mind sound up to a week before his death.

Mr. Churchill was born in Kentucky, moving to Illinois and Iowa, being married in the latter state. In 1851 Mr. and Mrs. Churchill and two children crossed the plains with ox team.

Mr. Churchill lived in Illinois during one of the famous Lincoln campaigns and liked to recall the happening and speeches of those stirring times. A widow and six children survive him. The children are A. P. Churchill and Mrs. L. C. Knox, of Cottage Grove; J. S. Churchill, of Marcola; II. H. Churchill, of Santa Rosa, Cal., and Mrs. C. Alley, of Roseburg.

EUGENE, Or., Aug. 31 .-- (Special.)--Mrs. Sarah E. Churchill, a pioneer of 1851, died last night at her home in Eugene, aged \$2 years. Her husband, William Churchill, died a few months ago. JOHN S. CHURCHILL is a well-known druggist and property owner in Marcola. He has had a broad experience, having been a rancher, business man and educator of prominence. He was born in Iowa, December 30, 1847, a son of William and Elizabeth (Lemon) Churchill, the father a native of Kentucky and the mother of Illinois. Both parents are still living. They were married in Illinois, where they resided until 1851, when they crossed the great American plains by ox teams and settled at Santiam. After remaining there for a short time they removed to Coles valley, in Douglas county, where the father took up a donation claim of three hundred and twenty acres of land and began to clear it and make improvements without delay. He remained on this farm

until 1866, when he sold out and removed to Polk county. After arriving in that county he purchased various tracts of land at different times, residing there until in 1880, when he removed to Lane county and retired. He is at present residing in Eugene at the age of eighty-seven years, while his wife has reached the age of eighty-five years. To them were born the following children, of whom J. S. Churchill, of this review, is the eldest, the others being: Mrs. Sarah L. Knox, of Cottage Grove, Oregon; Henry, of Santa Rosa, California; Alva, a resident of Bohemia, Lane County, Oregon; Mary, the deceased wife of E. J. Fenton, of San Francisco, California; Corinne. the wife of Frank E. Alley, of Roseburg, Oregon; and two who passed away in infancy.

John S. Churchill received a common-school education and later attended college in Oregon, in which state he was reared. At the age of twenty-two years he began his business career when he purchased an interest in a general mercantile store at Independence, in Polk county. He retained his connection with that business for two years, when, selling his interests there, he purchased a stock ranch in Marion county, which he operated for two years and then sold in 1874, removing to California. In that state he again became engaged in ranching and other occupations for four years. At the end of that time he sold his interests in the golden state and returned to Lane county, Oregon, where he taught school and conducted a nursery on a ranch which he purchased until 1903, when he became bookkeeper for the Fischer Lumber Company at Marcola, a position which he held for six years. In 1909 he purchased the drug store at Marcola which he still continues to operate, and in addition to the regular drug line he also handles many other articles. He owns a fine home in this city and also has various other properties including a livery barn,

Mr. Churchill was married in 1872 to Miss Ann E. Drinkwater, a native of Oregon, and unto this union were born seven children, as follows: Myrtle, the wife of E. B. Doane, of Springfield, Oregon; Karl, a resident of Pendleton; Ollie, who married William McDougal, of Washington: Earl, deceased; Howard, living in Springfield; Raymond, also of Springfield; and Zuleika, who has also passed away. From his first wife Mr. Churchill was legally separated in 1907 and later was again married, his second union being with Mrs. T. G. McMurry, the widow of Milton McMurry, and a daughter of Stephen Meriau. Mr. Churchill in his political views is an adherent of the republican party, having taken a commendable interest in politics as affecting the common good. He has been a justice of the peace, a notary public and a member of the school board for many years. Fraternally he belongs to the Masonic lodge, of which he has been secretary, and is also a member of the Independent Order of Odd Fellows, having filled all chairs in that order. Mr. Churchill, who is prominent in business and fraternal affairs of Marcola, is a well-known business man and the success which he has achieved may be attributed to his own well directed efforts. Starting out in life with practically nothing, he has succeeded in building up a substantial competence and as he is still vigorous and ambitious he continues in a business which is very satisfactory. He has an extended acquaintance in business, fraternal and social circles throughout the community and in the business world he is regarded as being one of the most reliable and solid men in Marcola." EARLY-DAY CITIZEN DIES JOHN S. CHURCHILL WIDELY KNOWN ALONG VALLEY. Normal Graduate Taught School in Lane County Many Years and Was Quite Prominent.

SPRINGFIELD, Or., Dec. 17.-(Special.)-John S. Churchill, well-known Lane county resident, died at his home at Marcola Monday. He was born in Iowa on December 31, 1845, and came to Oregon with his parents in 1851, settling near Roseburg. He attended the Monmouth Normal school for several years, and later taught school in Lane and other counties. He became one of the most prominent men in the county in its early days.

early days. In 1881 he moved to California, where he lived for a while, but moved back to Oregon in 1881 and lived at West Springfield for many years on a farm which is now known as the Seaver's Eugene auto camp.

Mr. Churchill was a member of the Christian church for many years, and also belonged to several fraternal organizations. He was a member of the Mohawk lodge, No. 200, I. O. O. F., serving as grand master for one year. He also belonged to the Illia encampment of the Rebekah lodge at Marcola.

He moved to Marcola in 1904, where he was employed as accountant and bookkeeper for the Fisher Lumber company for many years. Here he served for many years as justice of the peace, and always took an active part in all community enterprises. Surviving Mr. Churchill are his three sons, Carl, of Bend; Raymond, of Portland, and Howard, of Oakland, Cal. He also leaves two daupters

"O.F. Knox, a hardware merchant of Cottage Girove, was born in Schuyler county, Missouri, in 1845. His parents, Samuel B. and Cynthia (Stockton) Knox, were natives of Kcntucky and Tennessee, respectively. Emigrating to Missouri in 1843, Mr. Knox followed farming until 1853, when with his wife and ten children he started for Oregon. His outfit consisted of four wagons, sixteen yoke of oxen, 100 head of loose cattle and several fine mares. The trip was successfully accomplished, losing very few cattle, and landing in the Willamette valley, by the Barlow route, in September. Spending the first winter at Lebanon, in the spring of 1854 he came to Lane county and bought a claim of 160 acres, two miles east of Cottage Grove, to which he afterward added more than a thousand acres. He engaged in the live-stock trade, and made a specialty of raising fine horses. In 1876 Mrs. Knox died and he divided his property among his children, with whom he is passing the closing years of his life. O. F. Knox was educated in the common schools, at Willamette University and at Monmouth College, Polk county, where he graduated in 1871. He lived with his parents until 1873, when he was married in Polk county to Miss Sarah L. Churchill, who was also a graduate of Monmouth College and a daughter of William Churchill, pioneer of

1851. After marriage Mr. Knox settled upon his farm of 370 acres, one mile east of Cottage Grove. and engaged in fanning and the raising of livestock, keeping Cotswold shesp, graded Holstein cattle and a fine breed of horses. Of his farm twelve acres are in hops, 100 acres in grain and the balance is in pasture land. In 1881 he rented his farm and embarked in the butchering business at Cottage Grove, which he followed for five years. He then retired until 1890, when he former a co-partnership with I. M. White and opened a store for the sale of stoves, tin and hardware, which he still conducts.

Mr. and Mrs. Knox are the parents of six children: Mamie, Lottie, Roy, Duke, Lizzie and Frank. Mr. Knox is a member of the Knights of Pythias, is the present Mayor of Cottage Grove and is a representative citizen of the commonwealth." [Illustrated History of the State of Oregon by Hines p. 484-5]
