# Restated Bylaws of the Brooks Historical Society

An Oregon Nonprofit Corporation**Article I—Purpose** 

The Brooks Historical Society ("Society") shall gather, research, and make available materials relating to the history of the transportation, agriculture and cultural resources of the Brooks community for the education, enjoyment and enrichment of residents and visitors. The Society shall maintain the historic Brooks Railroad Depot as a museum.

In furtherance of its purpose, the Society shall perform such acts as may be necessary or appropriate for carrying out the foregoing purposes of the Society and to exercise any of the powers granted to nonprofit corporations under Chapter 65 of the Oregon Revised Statutes, ("ORS") as amended from time to time, and the Internal Revenue Code.

### Section 1: Terms and Conditions of Membership

Any person, interested in the objectives stated in Article I, may become a member under the terms of the Bylaws or as set by the Board of Directors of the Society ("Board"). The membership year will run from January 1 through December 31. The Board may establish the rights, benefits and duties of membership and set categories and fees from time to time.


#### Section 2: Policy of Nondiscrimination

Membership in the Society shall be open to anyone who meets the conditions of membership set forth by the Board. However, the Board shall set no conditions for membership that discriminate on the basis of race, religion, age. gender, residency or ethnic background.
