"An early pioneer, Dr. Charles Green Caples migrated across the Oregon Trail as a boy. After his marriage to Lucinda McBride, he studied medicine in Portland and passed the examination by the Board of Physicians for his degree. In 1870 he constructed his two story home on the same spot where his father Joseph Caples built his log cabin in 1846. The family lived on this land until 1959, when Dell Caples Houghton, a daughter of Charles and Lucinda Caples and a member of Mount St. Helens Chapter, Oregon State Society Daughters of the American Revolution, willed the house and property to the OSSDAR as a museum.

The Caples House Museum complex occupies a whole city block in the historic locality of Columbia City Oregon. Here, in 1870, on the banks of the beautiful Columbia River and with a majestic view of Mt. St. Helens, Dr. Charles Green Caples built his two-story home from logs cut near Monticello Washington, now called Longview. The house was occupied continuously by the Caples family until 1959." PIONEER WOMAN DIES

MRS. L. M. CAPLES, OREGON RESIDENT SINCE 1846.

**Funeral Will Be Held Tomorrow at
Columbia City—Five Children and
Other Relatives Survive.**

Lucinda M. Caples, widow of the late Dr. C. G. Caples, a pioneer of Oregon, died yesterday at her home at Columbia City.

Mrs. Caples was born in 1836. She came with her parents, Dr. and Mrs. James McBride, to Oregon in 1846, and was married to C. G. Caples in May, 1855. She resided in Columbia County from that time until her death.

She leaves the following children: Mrs. Margaret Wharton, Dr. Byron M. Caples, Miss Willie Caples, Mrs. Dell Shinn and Fred C. Caples. Other immediate relatives surviving her are her brother, Justice L. A. McBride, of Deer Island; Dr. J. H. McBride of Pasadena, Cal., and her sisters, Mrs. Louisa A. Woods and Mrs. N. E. Dolman.

The funeral will be held from the family residence at Columbia City tomorrow at 1:30 P. M.

CHARLES G. CAPLES, M. D.

Among the pioneer families of Columbia county, none had more influence in their respective communities or performed more distinctive service for their fellowmen than the Caples family, a worthy representative of which was the late Dr. Charles G. Caples, who, as an able, devoted and successful physician and loyal and public-spirited citizen, was for a long period one of the conspicuous figures of his section of the county.

The Doctor was born in Tuscarawas county, Ohio, on the 22d of May, 1832, a son of Joseph and Mary (Laffer) Caples, mentioned more fully in the sketch of H. H. Caples, which appears elsewhere in this work. In the family was only one daughter, Joanna, who was married in 1859 to George W. Maxwell, and for several years they made their home in Yamhill county, Oregon, but later removed to Clark county, Washington, residing there until the late '70s. They then removed to Columbia City, Oregon, where Mrs. Maxwell died but Mr. Maxwell's death occurred at Vancouver, Washington. In their family were two children: Lawrence V. Maxwell, who married and had three children: Lawrence V., Jr., now a resident of New York city, Charles H. of Columbia City, Oregon, and Lucille, of Kelso, Washington; while Chester B. Maxwell, is a resident of Wieser, Idaho. He is married and has one daughter, Muriel.

Dr. Caples lived in his native county until twelve years of age and in 1844 accompanied his parents on their journey across the plains to Oregon. He attended the public schools of Ohio and Salem, Oregon, also Tualatin Academy near Forest Grove, now known as Pacific University. In 1848, when seventeen years of age, he joined the gold rush to California, where he was engaged in mining about one year making enough money to pay the tuition and expenses of his sister and himself at Tualatin Academy. On leaving that institution he returned to Columbia City, and took a donation land claim of three hundred and twenty acres, a portion of which on the high land was heavily timbered, while the remainder was mainly rich river bottom land. He gave his attention to clearing this place, which he developed into a good farm, there spending the remainder of his life. After his marriage in 1855 he went to Portland and took up the study of medicine under the direction of Dr. Giltner, one of the ablest physicians of that city, and in the course of time passed the examination before the board of physicians and was granted the degree of Doctor of Medicine. In 1868 he was appointed state medical examiner for the insane at Monticello, Washington, in

which capacity he rendered effective service for three years, after which he returned to his farm at Columbia City, where he practiced medicine for many years. He possessed high qualifications as a physician, for which profession he was naturally fitted. In those early days the practice of medicine in this sparsely settled country meant long and tiresome trips, day and night, over often almost impassable roads, in fair weather and foul, to reach those who required his services. The record of Dr. Caples was replete with faithful service, as he spared not himself that he might relieve the suffering of the sick, and he commanded the unqualified confidence, esteem and gratitude of the people of his community. After many years of practice, he retired and lived quietly on his farm until his death, which occurred April 3, 1906, when he was seventy-four years of age.

On May 10, 1855, Dr. Caples married Miss Lucinda M. McBride, who was born in Missouri, a daughter of James and Mahala McBride, the former a native of Tennessee and the latter of Missouri. The family came to Oregon in 1846, crossing the plains with ox teams and covered wagons, and prominent among the pioneer families of this state. One of their sons, Thomas A. McBride, is now chief justice of the supreme court of Oregon. Mrs. Caples died September 4, 1916, leaving five children, as follows: Dr. Byron M., born at The Dalles, Oregon, is now a practicing physician at Waukesha, Wisconsin, and is the owner of the Waukesha Springs Sanatorium; Margaret A., is mentioned below; Willie L. is a resident of Arcadia, California; Dell M. is the wife of E. L. Houghton, of Santa Cruz, California; and Frederick C. is a mining engineer at Wedderburn, Oregon.

Margaret A. Caples, who was born in Yamhill county, Oregon, attended the public schools and completed her education in old Columbia City Academy. She remained at home until her marriage in 1883 to E. M. Wharton, who was born in Princeton, Illinois, and is a son of Samuel and Mary Wharton, both now deceased. Mr. Wharton was educated in the public schools of his native state, and in 1870 went to Kansas, where he lived until 1875 and then came to Oregon. After living here for a year he returned to Kansas, where he remained until 1882, when he came back to Oregon and bought one hundred and sixty acres of land at Columbia City. The land was covered with heavy timber, a large part of which he cut into cordwood and sold to the river steamboats. In the course of time he cleared a large part of the land which he planted to fruit, developing it into a valuable ranch. In 1883 he opened a general store at Columbia City, which he conducted for four years, and was then elected treasurer of Columbia county, serving in that position for six years. In 1904 he moved to Portland, Oregon, where he successfully engaged in business for eighteen years, and then returned to Columbia City, where he and his wife are now living. They have a comfortable and attractive home on the hill just west of the highway, commanding a splendid view of the Columbia river valley and the majestic snow-clad peaks of Mt. Adams and Mt. St. Helens. Mr. and Mrs. Wharton are the parents of three children, namely: Herbert M., born in Columbia City, is a member of the Masonic order and lives in California; Gertrude M. is the wife of R. O. Compton, of Waukesha, Wisconsin, and they have a son, Charles C.; and Louise M. is the wife of Leroy Larson, of Oakland, California, and they have a son, Paul W. Mr. Wharton is a member of St. Helens Lodge, No. 32, A. F. & A. M., at St. Helens. Mrs. Wharton is a student of Indian lore, being able to speak the languages of several of the Indian tribes of the Columbia river country and has written and dramatized a very pretty Indian play. She and her husband are greatly interested in the welfare of their city and county, standing for all that is best in the life of their community, and to a marked degree they command the sincere regard of all who know them.

HARRY H. CAPLES

Harry H. Caples, who is now retired from active business pursuits, is the oldest native-born resident of Columbia City, Oregon, where he is living within three blocks of the spot where he was born. He has led an active life, has met with fair success in his material affairs, and has well earned the leisure which he now enjoys. He was born on the old Caples donation claim on which now stands Columbia City, on the 11th of October, 1870, and is a son of Hezekiah and Minerva (Bonser) Caples, the former born in Tuscarawas county, Ohio, in 1834, and the latter in Columbia county, Oregon territory, February 21, 1854. His paternal grandfather, Joseph Caples, left Ohio in 1843 for Missouri, making the journey overland with ox teams. In the spring of 1843, with his sons, Hezekiah and Charles, and daughter, Joanna, (the mother having died in Ohio in 1838), he started for Oregon, crossing the plains with ox teams and covered wagons. They arrived in this state in the fall of that year and spent the first winter at Salem. In the spring of 1845 he went to Portland, which at that time consisted of one lone cabin. There he was offered a donation claim of six hundred and forty acres for five hundred dollars, but not liking the looks of the place or perhaps not having the five hundred dollars, he declined the offer. On that land the main part of the city now stands. He went on down the river towards Astoria and in 1846 filed on three hundred and twenty acres of land at what is now Columbia City. While on his way down the river, looking for a location, and when opposite what is now Columbia City, he saw a large eagle dart down to the river and grab up a large salmon. It landed the big fish on the bank of the river and Mr. Caples at once grabbed up his rifle and shot the bird, thus securing both the eagle and the salmon. It was a beautiful spot and they made camp there. He was so attracted by the place that he filed claim to the land. After building a log house on the river bank, he began cutting wood for the river steamers which were then beginning to ply the stream, but soon afterward went to Clatsop county, where he worked on a dairy ranch for a few years. He then returned to his claim and again began cutting wood for the steamboats, this serving the double purpose of affording him some revenue and of getting his land cleared of its heavy timber. He found on his land a lot of squared timbers, the presence of which puzzled him. Going to Fort Vancouver, he told Dr. John McLoughlin, the Hudson Bay Company factor, about them. The Doctor told him they were cut and squared by the Hudson Bay Company's men and were intended for building a new fort there, but that, because of the hostility of the Indians, the plan was abandoned. Mr. Caples took a deep interest in the locality where he settled and served one term as sheriff of Clatsop county. His death occurred in 1881. He was a man of strong character, great determination and personal courage, and bore his full share of the burden of the new community in which he settled.

Hezekiah Caples received a somewhat limited education in the public schools of Salem, Oregon, and assisted his father in clearing the ranch and planting an orchard. They gave their attention chiefly to raising of cattle, and raising hay sufficient to winter them. In 1889 Mr. Caples moved across the river into Cowlitz county, Washington, where he bought five hundred acres of land, on which he raised stock cattle, and later on ran a large dairy. He lived there until his death, which occurred November 26, 1921. His wife died February 24, 1903. Mr. Caples served six years as a member of the board of county commissioners of Cowlitz county, and was a member

of the Masonic order at Kalama, Washington. He was a steamboat captain and pilot and owned a vessel, which he sailed on the river for many years. To him and his wife were born four sons, namely: Harry H.; Ralph, who was a steamboat captain and died in 1921; Arthur, who is a widower and has a married daughter, Velma, now the wife of Austin Burt; and Hugh, who is married and has two children, Nineva and Donald. The three brothers live in Columbia City, and still own a large part of the townsite. The Indian name for Columbia City is "Kumahi."

Harry H. Caples attended the public schools of Columbia City and spent two years at Oregon Agricultural College, where he pursued a course in mechanics. After leaving college he assisted in the operation of the home farm for two years, and in 1897 he and two other young men took a trip to Rossland, British Columbia. In the spring of 1898 he went to Fort Wrangel, Alaska, and from there to Fort Simpson, British Columbia, where he worked for the Hudson Bay Company as assistant engineer on a steamboat on the Skeena river, transporting goods to the various posts, from which points they were carried by pack mules to the interior. The Skeena river is known as one of the most dangerous for steamboating in the northwest. Mr. Caples remained with the Hudson Bay Company four years and then returned to the home ranch at Columbia City, where he remained two years. In 1903 he went to Portland and, after taking an examination, was granted a chief engineer's license, after which he followed steamboating on the Columbia river for over twenty years. He and his brothers owned tugboats and Ralph was also a pilot and master mariner. In 1924 they sold their boats and Mr. Caples came back to the home ranch and, building a nice home in Columbia City, retired. He also owns a ninety acre dairy farm a mile and a half down the river, on which he is raising pure bred Jersey cattle.

In 1900, at Victoria, British Columbia, Mr. Caples was married to Miss Maude Graham, who was born in Oceana county, Michigan, a daughter of George and Albina (Hills) Graham, of whom the former was born in Illinois and is deceased, while the latter was born in New York state. Mr. Graham came to Oregon in 1881 and followed the business of commercial fishing on the Columbia river for many years. His death occurred in February, 1924, and his wife is still living in her own home and doing her own work, being remarkably active for her years. To them were born six children, Ernest, deceased; Edward, Maude; Albert, deceased; Elmer; and Orwin.

Mr. and Mrs. Caples are the parents of a daughter, Ethel May, who was born on the old donation claim in Columbia City and is the wife of Arthur Oberg. They have two children, Ruth Eleanor, born October 6, 1925, and Doris Jeanette, born March 3, 1928, they being the fifth generation to live on the old Caples homestead. Mrs. Oberg attended the public schools of Columbia City and graduated in 1921 from the Girls' Polytechnic School in Portland. Mr. Caples is a member of St. Helens Lodge, No. 117, I. O. O. F., in which he has passed through the chairs; also Golden Rule Encampment, at Portland, and Canton No. 1, P. M. at Portland. He and his wife are members of the Rebekah Lodge, I. O. O. F. Mr. Caples is a man of splendid personal qualities, honorable in all of his dealings and cordial and friendly in his relations with those about him, and throughout the community in which he lives he enjoys the genuine regard and good will of his fellowmen.

SUIT BEGUN TO BREAK WILL

Heirs of Cowlitz Pioneer, Who Married at 86, Allege Incompetency.

KELSO, Wash., Dec. 18.—(Special.)—Action was started this week in the Cowlitz County Superior Court by Harry Caples and others, heirs of Hezekiah Caples, a prominent Cowlitz County pioneer and owner of large acreage, to break the will left by Mr. Caples, who died a short time ago. Hezekiah Caples, aged 86, and his housekeeper, Emma L. Hansen, aged 27, were married at Cathlamet in June of this year. The plaintiffs allege the incompetency of Mr. Caples, mentally and physically, at the time of the marriage.

It is alleged that Miss Hansen and her sister had to assist Mr. Caples to the place where the marriage ceremony was performed and that he fell asleep immediately afterward. Other similar charges are made in the complaint.
